## 2013 FAWCO 41st Biennial Conference

*In a Timely Fashion: women • tradition • innovation*



Conference participants gathered for *Join me on the Bridge*, a worldwide initiative by Women for Women International to raise awareness about violence against women in war-torn countries.



Ambassador Betty E. King addressed conference attendees on International Women's Day which was celebrated globally on Friday, March 8.

FAWCO held its 41st Biennial Conference in Bern, Switzerland (March 6-9) with over 130 participants from 39 clubs representing every region except Region 10 (South American and the Caribbean).

It was a special honor to have Betty King, U.S. Ambassador to the United Nations in Geneva, speak to FAWCO on International Women's Day. Ambassador King gave an inspiring speech about the role of Women in Diplomacy and mentioned her own efforts to advocate for women at the Geneva-based global health organizations and in their development initiatives. She also emphasized how important it has been that Hilary Clinton, as head of the State Dept., made empowering women and girls the cornerstone of U.S. foreign policy.

## FAWCO Target Program Raised \$168,000 for Water

In 2009, the FAWCO Target Program was announced as a four-year program to bring a critical global issue to the attention of FAWCO Clubs. It was a focused strategy of education and project fundraising with the goal of highlighting one issue and looking for ways to solve the problem; and in so doing, assist in attaining the UN Millennium Development Goals. Clubs voted to decide on water as the Target issue and Tabitha Foundation's Wells for Clean Water in Cambodia as the Target Project.

# Overseas Americans Week 2013

FAWCO was represented by U.S. Liaison Lucy Stensland Laederich and U.S. Tax & Banking Chair Margaret Nelson Spethmann at Overseas Americans Week 2013, March 11-14 in Washington D.C. Joining a smaller-than-usual team from partners AARO and ACA, the delegates as a whole participated in over 80 meetings. In a polarized political environment, they still found sympathetic ears to listen to a number of their concerns:

## Access to financial services at home and abroad

OAW delegates explained the difficulties Americans are encountering with respect to bank accounts overseas (due in large part to onerous FATCA filing requirements imposed on foreign financial institutions) and in the United States (essentially because of Know Your Customer regulations that make foreign addresses a liability). Increasingly, Americans abroad are being closed out of U.S.-based investment accounts therefore finding investment and retirement savings options seriously limited.

## ACA proposal on residence-based taxation

ACA's international tax advisory council has prepared an exhaustively researched proposal for major tax reform, changing the current U.S. system of citizenship-based taxation to one based on residence, eliminating the need for great numbers of overseas Americans to report other than in their host country abroad. Many of the week's meetings dealt with this proposal, which appeared to meet with considerable interest on both sides of the aisle.

## Election reform

As found in the Overseas Vote Foundation 2013 post-election survey, many military and overseas voters continue to face obstacles to voting from overseas (technological glitches in downloading ballots, continuing problems of ballots not received in time to be returned on time, etc.). While more than half of these voters received their ballots electronically, close to 22% received no ballot at all or received it too late. Civil rights activist John Lewis of Georgia has introduced a sweeping election reform bill that addresses some of these obstacles. (HR 12, the Voter Empowerment Act) is now accompanied by a sister bill in the Senate (S 123, introduced by Senator Kirsten Gillibrand of New York).

One problem brought to the attention of legislators was the fact that the U.S. Postal System is scaling back service on Saturdays. For overseas voters, this could mean that ballots will not be sent out or delivered on time, meaning that the MOVE-mandated 45-day period between the sending out of ballots and the deadline for their receipt by election officials may be seriously compromised.

## News from the State Department

State Department officials described several legislative priorities, one of which should interest a number of FAWCO members: currently, a U.S. citizen married to a non-U.S. citizen and having a child born abroad can transmit U.S. nationality to the child if he/she has spent a total of five years in the United States including two after the age of 14. An unwed mother of a non-U.S. citizen child born abroad, however, must prove one year's continuous residence in the United States. As we have pointed out, this can

be difficult for a student, for example, returning abroad for the holidays. State now advocates allowing the unwed mother to choose either five years including two after the age of 14 or one year continuous, a position we can but applaud.

## Americans Abroad Caucus and "Talking to Congress"

Many of the FAWCO meetings were with offices of members of the Americans Abroad Caucus who, we feel, have a special interest in the issues important to overseas Americans. Because some members in the 112th Congress are no longer in Congress, the Caucus has declined in membership and we urge FAWCO members to contact their Representatives in the House (there is no equivalent in the Senate), encouraging them to join. There is no doubt that Representatives and Senators need to be reminded regularly of their overseas constituency.

A personal story: I met a couple of years ago with the Chief of Staff of Donna Christensen, (non-voting) Delegate from the Virgin Islands and an early member of the Americans Abroad Caucus. I mentioned that many people continue to bemoan the fact that overseas Americans have no Representative in Congress. He agreed, saying that while Representative Christensen cannot vote, she can sit on and even chair committees and can speak on the Floor like anyone else. He said, "It would give you someone to see when you come to Washington."

I replied that I did have someone: I regularly visited my Congressman Chris Murphy, of Connecticut (now my new Senator, whom I visited again in February). The Chief of Staff leaned back and said, "You know, you're right! If you could get all the members of your federation to write to and visit their Representatives, it would be much more effective than having a Delegate in Congress... because they vote!"

Take a minute to go to [www.house.gov](http://www.house.gov) and [www.senate.gov](http://www.senate.gov) and find your Representative and Senators. Don't just write to them when you are mad about some legislation. Write to them now to say you live overseas and represent a population of 6.32 million (latest State Department estimate) and that X and Y and Z are major concerns for you and many others in that population. If they don't hear from you, they can't possibly know what you're thinking!

#### **The Commission on Americans Living Abroad Act (HR 597)**

In early February, Representative Carolyn Maloney, longstanding champion of overseas Americans, introduced HR 597, a bill to create a bipartisan federal commission to look at the issues facing Americans overseas, including the military, and make concrete recommendations to Congress for solutions. Members of the Commission are to include members of organizations that represent United States citizens living in foreign countries.

Among the issues to be studied are 1) federal financial reporting requirements for U.S. citizens living abroad; 2) federal policies and requirements that affect the ability of a U.S. citizen living in a foreign country to access foreign and domestic financial institutions; 3) federal requirements for the spouse, child or other family member of a U.S. citizen living abroad to become a U.S. citizen; 4) the ability of a U.S. citizen living overseas to vote in federal, state and local elections in the United States, as well as Social Security, Medicare and student loan policies regarding U.S. citizens abroad.

FAWCO supports and applauds this important piece of legislation that, for the first time, takes a comprehensive look at how the federal government interacts with its citizens abroad. We also thank the Representatives who have signed on as co-sponsors and urge our members to encourage their own legislators to do the same thing!

#### **FAWCO Target Program Raised \$168,000 for Water**

So how many FAWCO clubs actually participated in the Target Program? According to a short club-wide survey:

- 78% of clubs participated in some way, that's 57 of 73.
- 10 clubs supported an alternative water project.
- 38 clubs planned a specific Target Program fundraiser.
- 20 clubs planned more than one Target Program event!
- Some clubs added a Target Program surcharge onto the cost of a regularly held event.
- 19 clubs planned specific water awareness events.
- 46 clubs put water awareness in their club's newsletter.

#### **These are great results for any program, but even more so for a new program!**

While our original donation goal was set at \$80,000 in honor of FAWCO's 80th birthday, our final amount raised was \$168,000. Total donation for Tabitha was \$140,000 while a number of clubs gave financial support to other water projects, which totaled to \$28,335. We have achieved over double our original goal!

## FAWCO and the United Nations

The UN, the U.S. Mission to the UN in Geneva, and FAWCO's work with the UN were all key topics at FAWCO's recent biennial conference in Bern, Switzerland.

### Trip to U.S. Mission in Geneva and UN HQ

The day before the FAWCO conference started, participants had the opportunity to visit the U.S. Mission to the United Nations in Geneva and tour the U.N. Headquarters at the Palais de Nations.

At the U.S. Mission, FAWCO members were introduced to women involved in various sections of the U.S. Mission who were working to increase the role of women and to enhance women's empowerment. Kim D'Auria-Vazira from the political section explained how under the leadership of Secretary of State Hilary Clinton, the role of women was emphasized more than ever at all policy levels.

Karen Glocer of the Economic and Scientific Affairs section described how important the role of technology was to women in developing countries. U.S. AID's Kris Easter focused on the fact U.S. economic assistance is now being viewed and judged through "a gender lens." Melissa Albuja of the Refugee and Migration Affairs section explained the importance of not only providing food and shelter in refugee camps, but also addressing unique problems women and children have there, particularly security issues associated with gathering of firewood.

### Eleanor Roosevelt Plaque at the UN

After the session at the U.S. Mission, participants had lunch at the headquarters of the International Red Cross followed by a visit to see the plaque honoring Eleanor Roosevelt's crucial role in the passage of the Universal Declaration of Human Rights (UDHR). FAWCO UN Rep Paula Daeppen and FAWCO U.N. NGO Director Pam Perraud described how FAWCO, along with other NGOs, fought to have the plaque erected in 2008, the 60th anniversary of the passage of the UDHR.

## UN's 57th Commission on the Status of Women

*The elimination and prevention of all forms of violence against women and girls*

The 57th Commission on the Status of Women in New York City was attended by a record number of participants. Expectations for this commission on the "elimination and prevention of all forms of violence against women and girls" were high. The last attempt by a U.N. commission to agree to a declaration on violence against women (VAW) in 2003 ended in failure, as did last year's commission on rights for rural women, development and poverty reduction.

During the commission, 6,000 global leaders, high-profile advocates, civil society and private sector representatives, government officials and 193 U.N. member states debated this fundamental human rights issue. Topics discussed included: "Analyzing the Economics of Violence against Women," "Promoting Sex and Human Rights Education," "Working with Men and Boys," "Ending Child Marriage," and "Addressing the Distinct Challenges of Violence against Girls." Delegates evaluated the progress that has been made on VAW since the 1995 Beijing Platform for Action for Gender Equality.

The end of two weeks of negotiation resulted in a document focusing on the prevention of violence and the need for: multi-sectoral support for survivors; rights for sexual and reproductive health; ending impunity for perpetrators; and building a database to inform an effective global response to VAW.

Sexual and reproductive rights were rallying points for conservative forces so the inclusion of emergency contraception for women who have been raped was a significant achievement. Contentious as they were, comprehensive sex education and stopping "child, early and forced marriage" were also included. Unfortunately, protection for sex workers and recognition of sexual orientation issues were not. Neither was language about "intimate partner violence," which may or may not be recognized by the state. However, the language stating that violence against women could not be justified by "any custom, tradition or religious consideration," which was under threat from Iran, Libya, Sudan and others, finally won the day.

Unfortunately, achievement was followed by disappointment when it was announced that Michelle Bachelet, currently the head of U.N. Women, would be leaving her post to return to Chile. Also, Egypt's Muslim Brotherhood publicly denounced the U.N. Document and called it un-Islamic, warning that it would "lead to the complete degradation of society." Fortunately, the chief Egyptian official at the meeting backed the accord seeing it as especially counter to "a global wave of conservatism, of repression against women."

Overall, the Commission was considered to be an outstanding success. Now it is time for implementation, action and accountability that will build on international agreements on women's rights before it, such as CEDAW.

# Obstetric Fistula

## *Education is the Key to Achieving MDG 5*

As the 1000-day countdown to the achievement of the Millennium Development Goals (MDGs) gets underway, U.N. Secretary-General Ban Ki-moon has asked to step up efforts, particularly where MDG 5 is concerned, saying: "Too many women die in childbirth when we have the means to save them."

Further stating that, "sexual and reproductive health problems remain the leading cause of ill health and death for women of childbearing age worldwide," the Secretary-General has pointed to the eradication of Obstetric Fistula as a key step towards achieving MDG 5.

Obstetric fistula is a devastating childbirth injury caused by prolonged obstructed labor in which a hole develops between the bladder and vagina and /or rectum and vagina, leading to permanent incontinence. Obstetric fistula is, in essence, the consequence of neglected childbirth and is therefore, fully preventable. Luckily, it is also treatable, with a 90% success rate.

The World Health Organization (WHO) estimates that there are three million women living with obstetric fistula, with an additional 100,000 new incidences every year. This type of childbirth injury accounts for 8% of maternal mortality cases and leaves the affected women suffering from pain and trauma due to incontinence, bladder infections, neurological disorders, orthopedic injury, kidney failure, infertility, stigmatization and social isolation. While obstetric fistula has been eradicated in the industrialized world, it is not uncommon in developing countries where women and girls often lack sexual and reproductive health rights and have limited access to education, finances or medical care.



FAWCO's Women's Health Issues Workshop featured the work of women's hope international (whi), a Swiss charity dedicated to fistula prevention, treatment plus midwife training (<http://www.womenshope.ch>) which was chosen as this year's conference charity.

In his most recent report to the U.N. General Assembly, the Secretary-General stated that the solution to eliminating obstetric fistula lies in addressing its root causes: poverty, gender inequality, barriers to education, child marriage and adolescent pregnancy. Moreover, the global health community has identified three basic interventions that can effectively eliminate fistula: 1) universal access to family planning, 2) trained health professionals with midwifery skills at every childbirth, and 3) timely access to high quality emergency obstetric and newborn care.

The United Nations Population Fund (UNFPA) put obstetric fistula on the world stage 10 years ago when it launched its global Campaign to End Fistula. This campaign spurred the collaborative efforts of governments, medical professionals and

civil society to restore the health and dignity of women living with this devastating affliction. Notable progress has been made as the campaign celebrates its ten-year anniversary, yet it is agreed that the eradication of obstetric fistula requires intensified efforts, including greater awareness, financing and human resources.

Most appropriately, this year's FAWCO Foundation Critical Health Concerns Development Grant was awarded to The Fistula Foundation(TFF) (<http://www.fistulafoundation.org>), which was submitted by American women of the Easter Province AWEF. TFF is a US non-profit organization that supports the work of the Addis Ababa Fistula Hospital in Ethiopia, the foremost medical center in the world devoted exclusively to fistula repair, founded in 1974 by Drs. Reginald and Catherine Hamlin.

Passionate about eradicating fistula, AWEF has been supporting TFF since 2007 and will be giving an additional \$3000 donation to the DG amount of \$4500. The total amount will make it possible for 16 women to receive a fistula operation plus... post operative care, a new dress, a bus trip home and their dignity!

Another keynote speaker was Megan Beyer, wife of US Ambassador to Switzerland Don Beyer. Mrs. Beyer, a journalist and regular contributor to *Le Matin* in Geneva, spoke passionately about gender equality and women in corporate leadership.

The speakers and UN Issues were the highlight of the conference: guest speaker Dr. Lisa Thomas of the World Health Organization introduced delegates to innovations in maternal health; Dr. Dorothea Hefti of Women's Hope International shared a moving presentation on their work in the field of obstetrics fistula; and Rosa Keller, a 16-year-old film maker, premiered her impressive work *Solutions*, a film on climate change. Global Aging Task Force chair, Kelly Fitzgerald (AWC Zurich), gave a workshop on Active Aging and FAUSA members, Ellen Mahoney and Judy Treanor, shared insights into repatriation challenges for teens, women and older persons. Lastly, author Preethi Burkholder gave a fascinating history lesson based on her book *17 Women that Shook the World* and examined the traits that made them extraordinary.

FAWCO delegates were treated to a lively panel Moving Mountains - Women and Politics in Switzerland. Switzerland's women only received their right to vote in 1972, yet by 2011, women formed the majority in the Federal Council, the seven member governing council of the country. Swiss political journalist Fritz Reimann moderated a panel of four women national council members: Claudine Esseiva, Margret Kiener Nellen, Christa Markwalder and Barbara Schmid-Federer, who talked about the long road of suffrage for women in Switzerland, the pros and cons of direct democracy giving anecdotal comparisons between Swiss and American politics.

Other introductions to Swiss culture included: conversations with Diccon Bewes, who gave delegates fascinating and amusing insights into the Swiss way of life based on his book *Swiss Watching*; a personalized tour of the Kunstmuseum's

collection of Swiss artists and special exhibit featuring Johannes Itten and Paul Klee; and a casual evening of Swiss Raclette and entertainment by the Swiss Alpenhorn trio and a quintet playing Swiss folk songs.

While Task Force and Committee chairs got familiar with the recently published Handbooks, the FAWCO Club Presidents had a working session with FAWCO experts on Tune Up your By-Laws and both Club Presidents and FAWCO Reps worked with Jeannine Brutschin on Engaging Your Club with Collaborative Story Telling. During the Best Practices Round Table, delegates shared stories about Bridging the Digital Divide with ideas about how clubs have successfully made the change to new ways of communication (electronic, social media, e-vites, etc.). All delegates got a chance to learn more about both FAWCO (at the Face 2 Face and U.S. Issues sessions), as well as The FAWCO Foundation programs during the four-day conference.

The Target Evaluation Task Force recommended that the Target Program support FAWCO's over-arching goal of improving the lives of women and girls. It also suggested shortening the Target Program timeline and cycle by launching new Target Programs rotating through FAWCO's four areas of focus on women and girls: Education, Environment, Health and Human Rights (refer to Resolution 1 of FAWCO's 2013-2015 Resolutions and Recommendations). Since the Malaria Project addressed Health and the Water Project was an Environmental effort, the two Boards (FAWCO and The Foundation) have voted that the next Target Program will be Human Rights for Women.

## AWC Lebanon's Aid for Syrian Refugees

Last year the American Women's Club of Lebanon (AWC Lebanon) donated \$2,000 worth of food boxes to Compassion Services which then supervised their delivery to the Syrian refugees in the North of Lebanon. This year the Syrian refugees' need for help is even greater, so the AWC Lebanon Charity Committee decided to donate another \$2,000 worth of food boxes to the Syrian refugees who have settled in Jbeil (Byblos). This donation was distributed to a small Muslim community lead by the Grand Mufti of Jbeil (Byblos) Ghassan Lakiss.

In March, Charity Chairperson Rihab Al Ouri along with AWC Lebanon members Sharron Labban and Betsy Mugharbil loaded two car trunks full of used clothes which had been donated by AWC Lebanon members and headed for the outskirts of Jbeil. They received a warm welcome from the Grand Mufti. Although the refugees were registered, little help had reached them in a long time.

The Grand Mufti Sheik Ghassan Lakkiss explained to the charity committee representatives that he also runs a clinic, Jamaeh el Nahda Al Khaireieh Al Islamieh. The clinic has physicians who administer general services for a discount as well as a dentist. The committee representatives visited the five-room clinic and were impressed by its immaculate condition. They were delighted to learn that the Grand Mufti had been approached by a Christian priest, who has offered to give English and Arabic lessons to the Syrian refugee children. Many of them have been without any schooling since they left their homeland.

## AWC Zurich's PHASE Philosophy

The American Women's Club of Zurich's (AWCZ) philanthropic work focuses on international efforts (FAWCO) as well as local efforts (PHASE-Philanthropy and Social Engagement).

Throughout the year, PHASE highlights different philanthropic opportunities for member involvement. For example, in the fall PHASE promotes the Pink Ribbon Run/Walk for breast cancer. Twice a year, they organize and promote fundraisers for Terre des hommes, a children's aid charity. At the FAWCO conference, AWCZ members got the idea to contact other clubs to see what they are doing on a local philanthropic level. Once the feedback is received, they will be sharing highlights back to all the clubs.

The Bern Conference inspired AWC Zurich to organize its own International Women's Day event for 2014. They are currently in the process of obtaining permission from the City of Zurich. Once this is received they will invite all their local

charities, as well as some city employees, to join them to further build relationships.

PHASE operates under the guidance of Margaret Mead's wise words: "Never doubt that a small group of thoughtful committed citizens can change the world; indeed, it's the only thing that ever has."
