2012 – Celebrating 15 years of ECOSOC status at the United Nations

2012 marked the 15th anniversary of our ECOSOC status at the United Nations. Peggy Rigaud, FAWCO 1st VP 1993-95, was invited to Dublin to share her personal account of how it came about. Here is an excerpt from her speech:

It all began in March 1993. A new FAWCO Board was elected, with Barbara Johnson of Paris as President, and me as first vice-president. Our first FAWCO board meeting was held in June in Amsterdam. Skype wasn't yet invented!

This was a meeting to define our goals for the next two years. Our ideas were good, but not revolutionary. But, our hostess had invited a guest to dinner - a former FAWCO president who lived in Amsterdam and she dropped a bombshell! The guest was Shirley van Ooijen; and her bombshell was that FAWCO should work to obtain status as an NGO recognized by the United Nations.

We soon realized that FAWCO, with its numbers, its geographical distribution, its members' profiles and interests, would be an ideal candidate. The term NGO, which originated with the United Nations, refers to not-for-profit associations with some wider social aim. There are thousands of them, including the Red Cross, Médecins sans Frontières, and the Girl Scouts. They have been called "civilian society's voice".

Barbara Johnson made achieving official NGO status an important goal of her presidency. I was enthusiastic about it too and I think she was happy to hand the legwork part off to me. So, I went home from Amsterdam and began to correspond with the United Nations. And by the way, almost all of this correspondence was done by fax except the part that was done by "snail mail". Before Amsterdam FAWCO didn't use email. The United Nations didn't use it either, as far as I know.

....and I, in fact, actually went home and bought my first computer. Times have changed!!

We targeted the U.N. Department of Public Information, or DPI. This department gives news about UN activities to selected groups which in turn passed this news on to their members. Since the United Nations wants its information disseminated, you might ask why it is necessary to obtain accreditation. But, it is. And it isn't all that easy or rapid a process. We were pursuing the DPI, but meanwhile FAWCO continued its normal business. In March 1994, we held our Interim Conference in Bern.

The "NGO concept" was new to all of us then, so I had recruited a friend who worked for the United Nations in Geneva as a speaker. We wanted her to tell us about the advantages of being a recognized NGO. So, in the course of her talk, what did she say but "of course NGOs don't lobby"?

Another bombshell! And a major one! Quiet pandemonium: ... there was a considerable group in FAWCO who, understandably enough, said that we had to stop this NGO process immediately since lobbying Washington in favor of U.S. citizens abroad was one of FAWCO's main activities!

We on the Board were convinced that this was a misunderstanding, but it took us a while to sort it out and establish that what she had meant to say was that NGOs are not "lobbyists" per se; that they do hands on work in the real world instead. And, they sometimes do lobby. We could, after all, be an NGO, and it would not keep us from pursuing our citizenship efforts!

In October 1994, there was a "UN Regional Conference" in Vienna, to prepare for the Fourth World Conference on Women to be held in Beijing China in the summer of 1995. This meeting offered separate NGO forums as well as the official meetings. NGOs needed accreditation to participate in the high level meetings, and only organizations whose work is deemed relevant to the platform are accepted at those. FAWCO was not yet officially recognized by the DPI. Nevertheless, we boldly applied to go to Vienna, and were invited to both the NGO forums and the high level meetings.

Barbara and I set off gamely for Vienna, determined to attend and to learn from the veterans how to negotiate the labyrinthine ways of the NGO world.

When we got there, we found some other FAWCO members. Helen Hootsmans from Amsterdam was there with a Dutch contingent. And we met a former president of the Rome club, Alicia Paolozzi. Alicia turned out to be an

old United Nations hand, and took it upon herself to explain the way things worked. She turned out to be a good person with whom to discuss getting things accomplished.

Vienna is of course a FAWCO city. The previous FAWCO president, Ann Day, lived there, and invited us for dinner. In the course of conversation around the table, the Days told us that accreditation with the DPI was good, but it was not going to be the end of our United Nations journey. The really desirable plum was affiliation with the Economic and Social Council, ECOSOC.

We'd been hearing that acronym for a few days....

So, back to the drawing board, as it were or back to my fax machine, as I sought information about how to be recognized by ECOSOC. By now, it is March, 1995, and there is a United Nations Conference on sustainable development in Copenhagen. Another FAWCO city. Again we were invited, and this time FAWCO was represented by members of the Copenhagen club. It was wonderful to have ready-made reps in all of these United Nations cities!

We were not affiliated with ECOSOC, and not yet even fully recognized by the DPI, but we had been invited to Vienna, so we were confident that we would be invited to China as well for the Fourth World Conference on Women.

Simultaneously, in March 1995, The FAWCO Conference took place in Nairobi, Kenya. We held a wonderful brainstorming session to define our "platform" for the Beijing Conference.

Our four goals for the United Nations concerned: Education, Eradication of violence against women, Environment, Work opportunities. At this same conference, our board's term came to an end, and Barbara and I became "NGO co-chairs."

On June 15, 1995, the United Nations Department of Public Information voted to approve FAWCO for affiliation.

Now, we could name representatives to attend United Nations meetings. And, five FAWCO members would receive accreditation to the Beijing Conference. In the end, seven of us went, and all of us were able to participate. The "FAWCO seven" were: FAWCO's new president, Becky Tan, of Hamburg, Helen Hootsmans, Amsterdam, Lois Pot, the Hague; Jeanne Schapp, London, Leslie Fiak, Taunus, Donna Sebti, Casablanca, and myself, from Languedoc-Roussillon.

Most of us spent our time there liaising with other NGOs, and becoming convinced that the "real work" was being done by them, much more than in the rather stuffy official meetings. We had gone armed with brochures introducing FAWCO and outlining our "platform". We distributed them widely. But mostly we watched and learned and were overwhelmed by our fellow delegates, especially the African group; they were there in force, in colorful clothes; often with no shoes; some of these women were illiterate, and all of them were making a difference in their towns and countries.

After China, The Hague gave a regional, entitled, "Back from Beijing and Beyond" part of the "beyond" was the pursuit of ECOSOC recognition. This required filling in reams of paper: submitting audited financial reports, giving evidence of our affiliation with the DPI (this is usually a prerequisite to ECOSOC membership). We had done things in the correct order even though at the time we didn't know it! Sending newsletters and articles on FAWCO club activities that were relevant to the Economic and Social Council's goals and learning in the process how very impressive FAWCO's member clubs and individuals are. I made long lists of activities carried out all over the world, under the auspices of FAWCO, in aid of women, children, education, health, the environment, etc.

On August 14, 1997, FAWCO was granted special consultative status by ECOSOC. This was a moment to celebrate! But naturally, it was not the end of the road. Ever since that date the members of FAWCO's NGO liaison have been working to keep us in good standing with ECOSOC. And they continue to submit detailed reports every four years.

I was asked: Do you think it has made a difference to FAWCO having the accreditation and status? How were we before?"

How were we, indeed?

I certainly cannot stand here and say that prior to having NGO status FAWCO was an organization of women in hats drinking tea. Indeed, we would never have been able to obtain our status if we had not already been a very impressive and active group of women! We were already involved in countless "United Nations" areas.

Outside of FAWCO, I believe that our UN affiliation has made us better known and appreciated.

Inside FAWCO, I would tend to say that the difference has been that we have become increasingly aware of how powerful we can be; of how much our work can influence the world scene; and I hope that our individual members will have increasingly realized that they are not alone and that, far from being “displaced persons” because we have left our home country behind, we are becoming more and more: citizens of the world.

FAWCO has had many big moments, and turning points; and it will have others; but this was definitely one of them, and I was glad to have been able to participate.

And now, before I leave you, a news flash: The United Nations chose March 8th of this year, Women's Day, to announce that, in spite of years of predictions to the contrary, there will be a 5th World Conference on Women in 2015! I expect to see FAWCO there!


The FAWCO Organization

Conference Procedures

The FAWCO President, the three Vice-Presidents, the Secretary and the Treasurer are elected at the Biennial Conference and serve for a two-year period, as do their appointees. Elections and terms of office are governed by the Bylaws. All voting that takes place during a Biennial or Interim Conference is limited to one vote per regular (at least 60% American membership) or associate (English the predominant language and consistently active participation of Americans in the leadership) Member Club. The Board of Representatives at a Conference must vote on the budget, all changes in dues and amendments to the Bylaws. The financial records of FAWCO are open to inspection by Member Clubs.

FAWCO OFFICERS' REPORTS

President's Report

It has been an honor to serve as FAWCO President 2011-2013. FAWCO has had some big moments in the last two years, from the success of the Target Program to the progress of our advocacy work in Washington, from the new frontier in member services to bringing focus to women issues, FAWCO has been busy and we have made a difference. Below are a few highlights of 2012:

Successful Interim Meeting in Dublin

The year started out with an extremely successful Interim Meeting in Dublin, Ireland hosted by the AWC Dublin. President Michael D. Higgins of Ireland was keynote speaker and delivered an audience-focused 25-minute speech applauding the work of FAWCO. The conference had 170 participants and guests and delivered a sizable surplus due to stringent budget controls and generous sponsorships. The FAWCO Board voted to devote a portion of this surplus to subsidize the 41st Biennial Conference in Bern (see conference report on page xx).

WOMEN as focus for FAWCO's work

At the request of our FAWCO UN/NGO team and as part of FAWCO's effort to participate more closely and more effectively with the UN, the FAWCO Board voted in 2012 to articulate our UN focus,, making what has been implicit explicit, and naming "Women" as the central theme of FAWCO's global outreach., Within that umbrella we have identified four specific areas: women and girls education, women's rights, women's health and women & their environment. This will clarify the work of FAWCO's global issues task forces and the Target Program – they must support the overarching goal of *improving the lives of women and girls*. In June FAWCO joined the UN Women National Committee of the United States. Pam Perraud, NGO Director participates in regular Board calls with local chapters in the US and will be participating in regular UN Women activities going forward.

I would like to especially recognize the Ending Violence against Women and Children (EVAWAC) Task Force for their activism this year. EVAWAC member Eileen Green-Doyle hosted the panel at the Dublin Conference about Ending Violence in Ireland, then the Task Force mobilized FAWCO clubs to join the 16-Day Campaign to end Gender Violence. In 2013, one campaign already planned is the Join Me on the Bridge campaign from Women for Women International. On International Women's Day, all FAWCO clubs are called upon to join FAWCO delegates in Bern on a bridge to bring awareness to violence against women in warzones.

Target Water Program raised over \$150,000

While FAWCO's first Target Program officially ended on December 31, 2012, a few clubs are still planning fund-raising events and donations will continue to be accepted until midyear 2013. By all measures, the Target Water Program has been extremely successful! As of February 2013, the Target Program has raised over \$130,000 for Tabitha Wells for Cambodia. In addition, clubs donated over \$20,000 to other water projects bringing the total money raised for this Target Water Program to over \$150,000 – that's nearly twice the original goal of \$80,000 set by the 2009-11 FAWCO Board.

One of the key goals for 2012 was increasing the number of clubs participating in the Program. Chair Anne Van Oorschot sent out numerous communications encouraging non-participative clubs to plan an awareness raising session or if possible, a small fundraising event. Her final report will be presented at the Bern Conference and included in next year's annual report.

In September 2012, the FAWCO Board commissioned a Target Evaluation Task Force, chaired by 3rd VP Monica Jubayli, with a cross-section of members from The Foundation, clubs and task forces to review and evaluate the Target Water Program and to recommend improvements for the next Target Program. Feedback was gathered through an evaluation survey sent out to clubs and FAWCO volunteers, and focus groups at regional meetings. The Committee presented their recommendations to the FAWCO Board in February 2013 and at time of print, these recommendations are still under review. Final recommendations will be communicated at the Bern conference and published in next year's report.

US Issues - Advocacy Hard at Work

In 2012, we partnered for the third time with Overseas Vote Foundation and offered our members a totally secure, dedicated voter registration and ballot request website. In April and November, FAWCO US Liaison Lucy Laederich met with a number of senior officials of the IRS and Treasury Department alongside representatives of AARO, ACA, Democrats Abroad and Republicans Abroad. The meeting was to understand the hardships imposed on overseas Americans because of new FATCA reporting requirements. Given the election-conscious climate in Washington, FAWCO did not attend Overseas Americans Week in 2012, but in January 2013, Lucy Laederich and US Tax and Banking Chair Margaret Spethman went to Washington during OAW and represented our interests in over 75 meetings with congressional offices.

FAWCO's work contributed to Reps. Carolyn Maloney (D-NY) and Mike Honda (D-CA)'s introduction of Bill [H.R.597](#), legislation to create a 15-member, bipartisan Executive Commission to study the impact of U.S. laws and Executive actions on the overseas Americans community.

As a result of much activity and interest in the FATCA topic, FAWCO has been featured in an unprecedented eight articles in the latter half of 2012 in such noted press as The New York Times, The Chicago Tribune and Le Figaro.

Disaster Relief Fund for Hurricane Sandy

In November 2012, at the request of AWC Antwerp, the FAWCO Board initiated a disaster relief fund for Hurricane Sandy. We followed the new DRF procedure laid out in 2011: that the requesting club must propose a beneficiary organization and that this organization must have a personal connection to the club. AWC Antwerp's FAWCO Rep Rozanne Vanrie had a personal connection to and proposed CAAAV as beneficiary of the fund. This small 501c3 has been providing services, materials, and emergency assistance to residents all across the hard-hit Lower East Side/Chinatown neighborhoods. Thousands of residents found insufficient help from the city, and were flooding the CAAAV office looking for help. The DRF was kept open until end of February 2013 and raised nearly \$3000. Thanks to AWC Antwerp, AIWC Cologne, AWA Rome and a few individuals for their generous donations.

Raising the Bar on Member Club Support

After successfully implementing the FAWCO best practices online library last year, in 2012, 2nd VP Elizabeth tirelessly rallied our clubs to populate it: 34 clubs have contributed over fifty best practices across the many areas of club development. The challenge now is for clubs to continue to use and keep it relevant and meaningful. In November, Club Presidents Coordinator Leslie Collingridge organized the first-ever FAWCO webinar. Michael Patterson, co-author of "Have a Nice Conflict: A Practical and Productive Approach to Interpersonal Conflict," talked to FAWCO-ites about "Don't avoid conflict - PREVENT IT!". Feedback was good and we will continue to explore this mean of communication to respond to the needs of our clubs. Club workshops on Tax & Banking were popular this year, FAWCO US Tax and Banking Chair Margaret Spethman and FAWCO's Platinum Sponsor US Tax and Financial Services delivered information sessions and presentations to six clubs as well as Region 9 meeting and more are already planned for 2013.

Increased Infrastructure

As a virtual volunteer organization, it is important that FAWCO strives to professionalize and standardize our work in order to offer consistent service to our members. With volunteers spanning four continents, several Handbooks and Guidelines were developed to make roles and responsibilities clearer.

- FAWCO Handbooks help volunteers understand the responsibilities of the Task Forces and Committees, their chairs and publication expectations: Target Program, Global Task Forces, U.S. Issues Committees, Administrative Committees.
- FAWCO Communications Guidelines give instructions on everything from letter heads to email signatures to webpage postings.
- Administrative Guidelines were reviewed and streamlined.
- Conference Planning Manual was updated to include key conference statistics.

In June 2012, the Archives for the Future Committee chaired by Kathleen Simon and Jackie Isler submitted their recommendations to the FAWCO Board. Amongst their key recommendations were a list of what should be archived and the different storage options (both physical and electronic documents). In September 2012 after 12

years of storage in AWC Zurich, the FAWCO physical archives were temporarily moved to the residence of Emily van Eerten in The Hague awaiting a new Chair and a new location. A substantial portion of the archives are in the process of being scanned with the intent that much of it will become accessible online.

Another important infrastructure implemented was the online club profiles. In the past, updates to club information and changes of FAWCO reps and club presidents were received by email and manually updated by the web manager or 2nd VP onto the FAWCO website. In addition, the FAWCO secretary had to annually contact clubs and updated the club information manually in the annual report. Now, the FAWCO Rep could go online and update her own club's information at any time directly into the FAWCO website. Everything is automatically generated from this online club profile: annual report information and FAWCO newsletter communications; therefore it is important that FAWCO Reps keep their club information current in their online profile.

Club resignations

Despite our best efforts, we had a number of clubs resigned in this term. In 2011 not renewing for 2012: AWC Aarhus, St Johns Woods Women's Club, American Club of Hertfordshire, International Newcomers Club Madrid and in 2012, not renewing for 2013: AWA Melbourne, Women's Association of Egypt, AW Amman, Thames Valley, Bordeaux Women's Club who only joined in March 2012.

There were different reasons given: clubs downsized or disbanded (Thames Valley, Hertfordshire, Aarhus); could no longer belong to an international organization due to a change in their host country's laws or political situation (Amman, Egypt); decided that their club's purpose does not enable them to benefit from a FAWCO membership (Melbourne and INC Madrid); or decided not to renew following their initial 6 month membership period as they did not have an opportunity to benefit from their FAWCO membership (St John Woods and Bordeaux). We invited these clubs to keep in touch with FAWCO and should their circumstances change and they are ready to offer their members the global dimension again, they are most welcome to rejoin the FAWCO global family.

I recommend that the FAWCO Board 2013-15 conduct a proactive membership drive to recruit new clubs, both American and International, and look at ways to identify and maintain contact with non-active clubs and better engage our membership.

First Vice President's Report

Communications

PUBLIC RELATIONS

Public Relations Manager, Amy Patrick

Amy Patrick, North American Connection, came on board as FAWCO external PR manager in November 2011 and there has been a plethora of external PR activities:

FAWCO in the Press: Amy brought press attention to FAWCO's Interim Conference in Dublin. As a result of the exposure that FAWCO received in Dublin, the spotlight continued to shine on the work of FAWCO US Issues task force and the work that they were undertaking in the area of expat tax rights and in particular the FATCA issue. Lucy Laederich represented FAWCO beautifully and reinforced the professional and diligent nature of the work of FAWCO.

- March 2012 - The FAWCO Interim conference in Dublin 2012 was featured in ExpatWomen.com. Andrea Martins has been a long time supporter of FAWCO, spoke at the 2010 FAWCO Annual Conference in Marrakesh in 2010 and has continued to highlight FAWCO work through her site throughout the year.
- March 2012 - The State Department highlighted Lycia Coble Sibilla, FAWCO NGO Representative, in honor of Women's History Month.
- March 2012 - To mark Women's History Month, Andrea Martins highlighted FAWCO on Expatica.com as a recommended network for Expats in France.
- March 2012 - FAWCOs Environmental Taskforce was quoted in, "How Can We Ensure Clean Water for all?", published in simplygreen.co.za.
- March 2012 – A press release drafted by Amy Patrick, dedicated to the Interim Conference in Dublin, was published in 1888pressrelease.com.
- March 2012 to July 2012 – FAWCOs work in the area of tax rights was highlighted various publications, Thomason Reuters, MailOnLine, Chicago Tribune, Le Figaro, The Ferguson Forum, evolvingexcellence.com, and Virtual Strategy Magazine.
- May 2012 – Lucy Stensland Laederich was quoted in New York Times Article, "Change to Ballot Request Form Angers U.S. Expats.

This media attention is an aspect of FAWCO that needed to be developed and the work that Amy has put forward is a fantastic first step. FAWCO must continue to develop this side of communications and strive to gain media attention for FAWCOs good work to attract new members, assist in spreading the word on issues that are vital to American expats, increase advertising potential and to assure the success of programs. Clubs must be reminded more regularly that when they receive media attention, they should reiterate that they are a FAWCO club. This will be of benefit to the entire FAWCO network, demonstrating that FAWCO is a unified group that is responsible for real and positive change for American Expats and the world as a whole due to FAWCOs global work.

Brochure

The new FAWCO brochure was created end of 2011 and has been distributed through different events and venues. This brochure highlights FAWCOs four core activities; Membership Support, US Issues, Global Issues and Philanthropy and the small investment that has been made to produce this document has been recovered through the benefit of the message that it has delivered thus far. FAWCO aligned with Overseas Domestic Violence Crisis Center (AODVCC) to have the FAWCO Brochure distributed during their own PR activities in face-to-face visits in South America. This sort of joint-marketing collaboration with other international organizations is a good opportunity for FAWCO and further opportunities should be sought out in the future.

ADVERTISING

Advertising Managers, Patricia Shea and Denise Donaldson

The communications team grew substantially at the Interim Conference in Dublin after a request for volunteers during 1st VP presentation. Patricia Shea and Denise Donaldson come forward as enthusiastic advertising managers and have been working toward bringing new advertisers on board since this time. Patricia and Denise are both highly professional additions to the Communications Team and have brought a creative approach to advertising and have diligently offered their time to increase advertising partners.

The acquisition of new FAWCO advertising partners has proven difficult this past year despite the expanded advertising team. Feedback from various clubs has clarified that this has been an issue for FAWCO local clubs as well. As a majority of FAWCO clubs are concentrated in Europe and considering the economic difficulties that this region is experiencing, the difficulty of recruitment is not without explanation.

Joint Advertising

The concept of joint advertising was introduced during the Interim Conference in Dublin. Joint advertising consists of advertising partners working closely with FAWCO and individual clubs to spread their message in a dynamic manner. This type of advertising would allow for a broad message to all FAWCO members but also the ability to target specific regions in which the advertiser is interested. This arrangement has the potential to bring financial benefit to FAWCO clubs through referrals, but more importantly it presents the opportunity for FAWCO and local FAWCO clubs to collaborate, spread the FAWCO message and build stronger bonds that will endure in the long term.

Advertisers

In 2012, FAWCO has two major advertising partners; US Tax and Financial and Volvo. A third long time partner is Clements who declined to renew their contract for 2012. Clements chose to sponsor the Interim Conference in Dublin and after negotiation they were brought back to FAWCO with a logo link on FAWCO's homepage.

Separation of Advertising and Conference Sponsorship

The Advertising Rate Card was revamped last year and a significant change to the format was that the conference sponsorship element was removed and all sponsorship responsibility was transferred back to Conference Organizers. A caveat of this new configuration was that FAWCO advertising and Conference organizers would need to work closely together to assure that we approach potential advertisers and sponsors with the correct and clear message of supporting FAWCO.. In 2012, this approach proved successful in gaining US Tax & Financial and Clements as both conference sponsors and advertisers.

US Tax and Financial

The relationship that has developed with US Tax and Financial Services has been a mutually beneficial relationship which has been an important goal of FAWCO advertising. A stronger relationship would ensure long term support of FAWCO. US Tax and Financial Services have offered presentations to member clubs free of charge and to date, there have been six presentations at FAWCO clubs. US Tax and Financial Services are experts in the area of American Expat taxes and offer valuable information to our members. They have the ability to prepare US tax returns with ease with the assurance that their approach is a solid one that brings clients into compliance with US Tax obligations which continue to become more complicated and stringent. The feedback from these presentations has been extremely positive and this type of relationship is something FAWCO would like to nurture with other advertisers who have the ability to offer our membership such a level of expertise. US Tax and Financial Services continued their Platinum Partnership through 2013. It should be noted that FAWCO does not influence members to use US Tax and Financial Services for their tax needs but rather, offers US Tax and Financial Services as an alternative and the ultimate decision needs to be made by individual members.

Clements

The goal is to bring Clements back on at a higher level. Though this was not achieved in 2012 but the goal is still in place for 2013. Our relationship with Clements continues to develop and this goal appears to be achievable.

Clark and Rose

New advertiser Clark and Rose came to us through 1st VP (Michele Wirt moved from Switzerland to Australia with Clark & Rose). They decided on a Silver Partnership package in November of 2012 for the year 2013. We look forward to a fruitful partnership with this relocation company.

Vonage

At time of print, we are in talks with Vonage for conference sponsorship at the Bronze level for Bern. Gaining Vonage as a new advertiser will be the focus in 2013.

FORUM

Forum Copy Editor Kristina Didouan, AAWE Paris and Forum Layout Editor Amy Patrick, North American Connection

The FORUM, distributed electronically to all club presidents, FAWCO reps and other subscribers, continues to be an efficient, cost effective form of official communication. The approach to distribute the Winter FORUM 2012 was slightly altered with an email that highlights the different articles and offers the reader the ability to click on links that will bring them to an open FORUM on fawco.org. The ability to download a PDF version was also an option that was available in addition to the links to specific articles. In addition, 250 copies of the FORUM were printed and distributed to clubs with clubhouses, European US consulates/embassies, and distributed to Congress through US Liaison Lucy Laederich and to our UN colleagues through the NGO team.

US Tax and Financial and Volvo continued in 2012 as print advertisers in the FORUM. A sincere ***Thank You!*** goes out to all those who contributed articles. Tighter deadlines and more stringent formatting requirements were put in place to guarantee smooth production which was improved even further this year. The quality of the articles and the adherence to these requests are much appreciated.

Another huge ***Thank You!*** goes to Kristina Didouan and Amy Patrick for their professional approach which produced these beautiful issues.

Website

Website Manager, Cat Conner, AWC Hamburg

Cat Connor has now been with FAWCO for over two years and the value of her insight and expertise in all things technical that she brings to fawco.org, is confirmed with each task that she undertakes. Her professional approach is reassuring and a huge benefit to FAWCO, we are very fortunate to have her on board. Cat also offers free online assistance to members clubs with technical issues; this is a benefit which clubs should use to their advantage.

The following areas were added to fawco.org; “FAWCO Books”, “FAWCO in the News”, “Americana”, “College Guidance”, “Press kit”, “Best Practices Library”, “Online Club Profiles” and a revamped “Member Clubs” area which is accessible from fawco.org home page. These areas are an added benefit to FAWCO clubs but also to fawco.org visitors. The areas continue to develop over time and contributions are welcomed such as books from our clubs or individual members, best practice stories or news items that concern FAWCO. We are pleased to see these areas grow, look forward to further growth and also look towards adding other relevant content which adds value for FAWCO members.

Social Media

Social Media Managers, Melissa Roy (FAUSA) and Ellie Badanes (FAUSA)

The FAWCO communications team grew during the Interim Conference in Dublin with the addition of our Social Media Manager, Melissa Roy. Melissa was president of AWC Dublin until early 2012 and she currently resides in Ft Lauderdale Fl. The FAWCO Facebook page continues to receive RSS feeds from fawco.org and as of September 2012, it also receives feeds from The FAWCO Foundation’s website. FAWCO wishes to nurture and further strengthen these types of collaborations with our sister organization. In addition, FAWCO Facebook page receives direct statuses from FAWCO Social Media Manager Melissa Roy who has been highlighting anniversaries of clubs, announcing the completion of Club Profiles as well as other important news coming from FAWCO. In December 2011, FAWCO Facebook page had 138 “likes” and a year later this number has come close to doubling to 242 likes. This increase in likes is attributed to the increase of important content and FAWCO will continue to nurture the Facebook page and provide the most relevant up-to-date content available. FAWCO is actively requesting members to “like” FAWCO Facebook page and pass it along to other expats who will benefit from the content.

FAWCO Flickr and YouTube pages have been in use since Boston and have grown and developed during the Marrakesh and Dublin Conference. The quality of video uploaded onto Youtube and the number and quality of photos uploaded onto Flickr has increased over time. FAWCO will strive towards increasing quality to bring our members around the world the closest alternative to a live broadcast. FAWCO Twitter account already exists and was used sparingly during Boston and Marrakech and more consistently during Dublin with thanks to Ellie Badanes! She will live tweet at Bern in 2013 using FAWCO2013 and #fawco2013.

WebHosting

Web Hosting Coordinator: Debbie Hastings

Currently, 30 clubs are web hosting with FAWCO with a further club expected to begin hosting in 2013. In 2009, FAWCO changed to HostGator from Hosted Solutions for better service and pricing, and this change continues to prove the correct decision was made changing to HostGator. We are able to offer our webhosted clubs a very reasonable price of \$8 per month, with a competitive set of technical specifications.

Second Vice President's Report

Member Clubs

At the Dublin Conference last March, I set the goal to complete what had been started – institutionalizing the sharing of best practices through our online library and bringing the knowledge and expertise within FAWCO to clubs through workshops and presentations. The year also brought new challenges, unexpected successes and many surprises. You never know what will happen when wonderful women around the world engage and work together to make a difference.

The Online Best Practices Library

To date, 34 clubs have contributed 54 best practices in the areas of: club management, communications, fundraising, external relations, membership, activities and other. We are confident that FAWCO Reps will continue to both give and take from this vibrant and growing resource that only a network like FAWCO can provide.

The “Bring FAWCO to Your Club” Program

The program has seen Margaret Spethmann (US Tax and Banking Committee Chair) and our sponsor US Tax and Financial Services traveling to individual clubs and regional meetings to give presentations on developments in these areas for Americans abroad. Kara Fairchild (Environment Task Force Chair) also gave a presentation on “Your Water Footprint” for the Region 2 meeting in Stockholm.

In addition, President’s Coordinator, Leslie Collingridge, organized a first for FAWCO – a webinar for Presidents on the topic of conflict resolution, led by a co-author of the book “Have a Nice Conflict: A Practical and Productive Approach to Interpersonal Conflict”. We will have more of these initiatives in the future that respond to the needs of our clubs.

Online Club Profiles

On the back-end, we have successfully transitioned to an online database system for keeping up-to-date information on our clubs (thanks again to FAWCO’s webmaster Cat Conner, AWC Hamburg) and FAWCO Reps are adapting to a new way of updating their club information. The next step is institutionalizing the online profiles at the local club level from one FAWCO Rep to the next.

Communications

The “News in Brief” newsletter provided monthly contact between the world of FAWCO and our local Reps and many members used the various FAWCO Facebook pages to share ideas, information and personal news. Region 9 was the first region to set up a Facebook page specifically for the Region 9 meeting hosted by AWA Doha and this proved to be a successful way to keep everyone up-to-date on the logistics and agenda and start conversations before arriving in Doha. Regional Coordinator Kelly Al-Nashmi proposed the idea and set it up while FAWCO Rep Mary Starrett posted daily. What a team!

FAWCO Website

A new “Member Clubs Area” has been created on the website, with guidelines for new reps, information on how to update your club profile, the Directory and Member Club’s online profiles and much more. The one-stop place for everything you need to empower your club to take advantage of the FAWCO experience.

Regional Meetings

In addition to Region 9 (Middle East), the following regions held meetings in 2012: Region 2 (Scandinavia and Russia) hosted by AWC Stockholm, Region 4 (Be-Ne-Lux) hosted by AWC Amsterdam, and Region 5 (Germany and Austria) hosted by the Augsburg International Women’s Association.

Club Membership

Over the year we lost nine clubs, each one with its own story -- clubs closing, downsizing, changing their focus and activities or in the midst of difficult political situations: St. John's Wood Women's Club, American Club of Hertfordshire, Thames Valley American Women's Club (Region 1), AWC Aarhus (Region 2), Bordeaux Women's Club (Region 3), International Newcomer's Club of Madrid, Women's Association of Cairo (Region 7), American Women of Amman (Region 9) and the American Women's Auxiliary to the Royal Children's Hospital of Melbourne (Region 11). We are confident that other clubs will be joining whose mission and activities are a good fit with those of FAWCO.

Philanthropy

In addition to their local charities, clubs showed rousing support for the Target Water Project and also contributed to the FAWCO Disaster Relief Fund for victims of hurricane Sandy initiated by AWC Antwerp. Nine clubs also responded to FAWCO's Ending Violence against Women and Children Task Force's call for action to participate in the "16 Day Campaign" to end gender-violence.

Regional Coordinators

We are very pleased to have new Regional Coordinators for Region 11 (Asia, Australia and New Zealand), Pam Weiden of AWC Shanghai and Katherine Balfour of AWC Perth, and Region 2 (Scandinavia and Russia), Kara Fairchild of AWC Gothenburg. Regular Skype calls amongst RCs were institutionalized this year, where RCs connected, shared experiences and formed a team. As a result, they feel more empowered and supported in championing FAWCO and mobilizing their region. They keep FAWCO connected to each and every club around the world. I have appreciated their enthusiasm, hard work, support and also greatly enjoyed their company!

FAWCO Reps

THANKS to a fantastic group of women! They are the heart of FAWCO, pumping information and enthusiasm back and forth through the veins of their local clubs. At the Dublin Conference in 2012, four FAWCO Reps were recognized for their outstanding service: Alma Lou Annab (American Women of Amman), Donna Haas (AWA Dubai), Robin Meloy Goldsby (AIWC Cologne) and Clydette De Groote (AWG Paris).

These two years have passed quickly, I leave a legacy of a few new tools and systems that will make it easier for clubs to connect. It will be up to you to put them to their best use to empower your club to take full advantage of the FAWCO experience.

Thanks to all the Regional Coordinators, FAWCO Reps, the President's Coordinator, the webmaster, the task force chairs and other FAWCO chairs and the board for your support over my two-year term.

Third Vice President's Report

Administrative, Global Issues & US Issues Committees

This past year my responsibilities as Third Vice President for Committees included overseeing the Administrative and US Issues Committees, the Global Issues Task Forces as well as the Target Program. As you will see from their reports below, the Committees and Task Forces have been busy this year supporting the four pillars of FAWCO: Club Support, U.S. and Global Issues, and Philanthropy.

The Administrative Committees (Archives, By-Laws and Administrative Guidelines, Finance, Membership, Nominating, Resolutions and Recommendations, Site Selection) are responsible for keeping FAWCO running like a Swiss watch. The Archives for the Future Committee completed the work begun last year and submitted their recommendations (see report below) to the Board. Since this year we are holding the Biennial Conference, the Nominating and R&Rs Committees have been activated to help guide FAWCO's future direction.

The U.S. Issues Committees (Citizenship, Tax and Banking, Voting from Overseas) have been very active during 2012. Particularly helpful, the Tax and Banking Committee endeavored to inform members about how to sort through these complex issues. The Voting from Overseas Committee worked overtime to ensure we were able to cast our votes and make our voices heard during this election year.

The Global Task Forces (Education: Americana, College Guidance, Students Who Learn Differently, Ending Violence against Women and Children, Environment, Global Aging, Health Issues, and Sharing Cultures) continue to keep FAWCO members informed on crucial issues that affect us all. Especially energetic in 2012 was the EVAWAC Task Force, co-chaired by Tonya Teichert and Erica Higbie and ably assisted by their Executive Committee, Karen Lewis and Therese Hartwell, encouraging clubs to participate and take an active role in ending violence against women and children through various initiatives.

As the Target Program comes to an end, a Target Evaluation Task Force was formed in September to review the entire process and to make recommendations to the Board concerning ways to improve the selection process and implementation of the next Target Program. The Board is currently reviewing these recommendations and will communicate them at the Bern Conference. The full report will be published in next year's Annual Report. I would like to thank Anne van Oorschot, Elsie Bose, Karen Lewis, Pam Perraud, Sara von Moos, and Tricia Saur for volunteering on this important task force.

Volunteers are the lifeblood of FAWCO, and without them we could never achieve our goals to support the Four Pillars. There is always a need for creative ideas and a fresh perspective, and so I make my plea to recruit new volunteers.

After many years, Jackie Isler is retiring from her job as Archives Chair, and for the time being, Emily van Eerten has taken up her duties, temporarily. Janelle Mason, having worn many FAWCO hats, is giving up her co-chair position on the Membership Committee to make more time for her FAUSA duties.

While Laila Alamuddin has done her best to work on U.S. Citizenship issues from Stateside, she is planning to resign to better focus on Education: College Guidance, as Sallie Chaballier gives up the chair and moves into the position of FAWCO 2nd VP. This year Eric Way has stepped down as co-chair of Tax and Banking but remains an active member of the Committee. Cynthia Smith-Ayed's new position on the FAWCO Foundation Board as 1st VP meant she was unable to stay on as Voting from Overseas co-chair.

Unfortunately, Kelly Fitzgerald (Global Aging Task Force), Sylvia Cox (Health Issues Task Force), and Elizabeth Kelly have all had to resign. In fact, Global Aging, Health Issues and Sharing Cultures Task Forces are in desperate need of co-chairs as the current chairs have a lot of passion, but very little time to keep these Task Forces active. We need your help.

In summary, we are looking to fill the following Chair /Co-Chair positions:

- Archives Chair - (Ideally, someone who lives in the same city/country as the Archives, currently located in the Netherlands.)
- Citizenship Committee Chair
- Voting from Overseas Committee Co-Chair – working with Mary Stewart Burgher (AWC Denmark)
- Tax and Banking Committee Co-Chair – working with Margaret Spethmann (AWC Hamburg)
- Membership Co-Chair – working with Terri Knudsen (AWC Denmark)

- Global Aging Task Force Chair
- Health Issues Task Force Co-Chair -- working with Regina Weber (AWEP)
- Sharing Cultures Task Force Chair

In an effort to make things easier for new and continuing volunteers, a series of Handbooks (for Administrative Committees, US Issues Committees, Global Task Forces, and the Target Program) has been published on the FAWCO website. They give detailed information about the Committees/Task Forces and of what is expected of the chairs and Committee/Task Force members. Specifically, the Board feels that it is important for the Committees/Task Forces to stay in touch with the members and to promote club involvement through some sort of themed event or initiative. These events/initiatives would ideally be promoted FAWCO wide, encouraging as many clubs to participate as possible, with the FAWCO Reps and Regional Coordinators helping to coordinate the efforts. It is essential, in order to promote club involvement to produce an article or a bulletin, at least once a quarter, in order to remain relevant. In order to assess that relevance, it is important to not only regularly update the webpages, but to also keep track of the interest generated by the Committee's/Task Force's publication.

It is hoped that these Handbooks will not only make for more efficient Committees and Task Forces but will also improve the way the Committees and Task Forces keep clubs involved in US and Global Issues by staying current and relevant. In this way our volunteers are truly forming the foundation for FAWCO's Four Pillars. A huge thank you goes out to all of our volunteers, past and present, who keep the FAWCO clock ticking in a timely fashion.

Treasurer's Report

I thank you for the opportunity to serve as FAWCO Treasurer this past term. I still believe that together, with all of FAWCO's members, we have and will continue to make a difference. Following is a summary of what has been happening since our last conference.

The organization continues to remain financially healthy. The balance sheet is now reflecting more of a true "Fund Accounting" perspective by segregating Equity into the various temporarily restricted funds the Board has agreed upon. These balances represent monies still available for distribution for their intended purpose. At the end of this fiscal year, I will make the necessary adjustments to continue to reflect this segregation.

Although we approve a two-year budget, I have included only one half of the adopted budget (one year), in this report, and have asked the Finance Committee to review a revised budget that better fits the new structure for QuickBooks. In preparation for the Finance Committees report, I would like to highlight a few areas:

- **Contribution Income:** In the past this was referred to as Donations. It represented monies received that FAWCO would then turn around and donate, i.e. Disaster Relief Fund (DRF), Eleanor Roosevelt Girls Leadership Workshop (ERGLW). Because these are funds being received by FAWCO, I have chosen to call them contributions and the monies being donated, as a result of these contributions, are listed as donations under expenses. Because we never know if we will receive contributions from clubs, individuals or in-kind, this line item is not budgeted.
- **Advertising Income:** This is a very aggressive budget, especially since we have struggled over the past two years to reach our current budget. We have recently added two new advertisers. We hope to continue to bring in new advertisers and renew old contracts over the next two years.
- **Sales:** This is made up of FAWCO items sold i.e., scarves, pins, re-usable bags. The Cost of Goods Sold represents the cost of the items being sold.
- **Program Income:** Represents the sum of Membership Dues, Web Hosting Fees, and Domain Registration Fees.
- **Conferences:** Represents the cost for speaker and volunteer gifts, as well as stipends to Committee Chairs and/or Regional Coordinators.
- **Operations:** Reflects most other costs of running the organization, i.e., printing, postage, bank fees, supplies, etc.

The Finance Committee will present a proposed budget for the next term based on the actual information from the current term's actuals and new Quick Books format.

Because all billings and receipts are being done via e-mail, it is essential we have correct contact names and e-mail addresses. Thank you for continuing to update us with this contact information.

This past November it was voted to establish a DRF for Sandy. At the time of printing, I am happy to report we raised a total of \$2,672. This amount will be sent the end of February.

Last year's conference came in under budget. As a result, FAWCO received \$6,615. The board voted to separate any funds received, as a result of a surplus, and apply them as a subsidy for future conferences thus providing a discount to the members attending. Keep in mind, when a surplus exists, it is usually a direct result of Sponsors coming in at the last minute which are difficult to budget for.

Included in this Annual Report are the Balance Sheet as of January 31, 2013, the YTD Statement of Income for the same period and a comparison of budget vs. actual for the same period. Also included is the Annual Report for FAWCO's fiscal year May 1, 2011 thru April 30, 2012, including a statement of review and approval by an independent auditor.





FEDERATION OF AMERICAN WOMEN'S CLUBS OVERSEAS**NOTES TO FINANCIAL STATEMENTS****1. THE FEDERATION AND ITS OPERATIONS**

Founded in 1931, FAWCO is an international network of independent volunteer clubs and associations. There are more than 75 member clubs in 40 countries worldwide, with a total membership in excess of 15,000. FAWCO serves as a resource and channel of information among its members, promotes the rights of U.S. citizens overseas; is active as a Non-Governmental Organization (NGO) with consultative status to the UN Economic and Social Council; and contributes to the global community through its Task Forces and The FAWCO Foundation, which provides development grants and education awards. FAWCO and The FAWCO Foundation also collaborate on emergency funding for disaster relief.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

a) Basis of preparation

The financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS"). The financial standards have been prepared under the accrual basis using historical cost convention.

The preparation of financial statements in conformity with IFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the association's accounting policies.

b) Inventories

Inventories are stated at historical cost.

c) Cash and cash equivalents

In the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with banks

d) Accounts receivable

Accounts receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection is expected in one year or less, they are classified as current assets.

e) Temporary Restricted Net Assets

Temporary restricted net assets represent those assets which either have a restricted use or have been designated for a specific purpose. This restricted nature prohibits them from being used in the normal course of business. As a result, management has elected to present these assets in the Fund Balance section and classify them as a reduction in Fund Balance. These assets are stated at historical cost.

f) Foreign currency translation

The U.S. dollar, the currency in which substantially all sales are priced, is the functional currency for FAWCO's operations. Non-U.S. dollar asset and liability accounts are translated at year-end at the U. S. State Department average rate of exchange during the fiscal period reported. Income statement transactions in currencies other than the U.S. dollar are recorded at rates prevailing at the time of the transaction.

3. CHANGE IN ACCOUNTING POLICIES

AS of the beginning of the current fiscal year, management elected to change from the cash basis of accounting to an accrual basis of accounting. In accordance with International Accounting Standard 8, this change in accounting policy has been applied retrospectively, where practicable, to the accompanying Balance Sheet and Statement of Cash Flows for the fiscal year 2011. The cumulative effect of this change has been identified.

2012 CONFERENCE REPORT

41st Interim Conference – Dublin, Ireland “A Hundred Thousand Welcomes!”

FAWCO held its 2012 Interim Conference in Dublin, Ireland (March 21-24). We had the honor to receive the President of Ireland, Michael D. Higgins who gave a 25 minute speech applauding FAWCO’s work and volunteerism. FAWCO was also welcomed by Jimmy Deenihan, Minister of Arts, Heritage and Gaeltacht Affairs, who stressed the special bond between the United States and Ireland. Our guests of honor for the Opening Dinner were the Lady Mayoress of Dublin, Sinead Ahern and Chargé d’Affaires from the US Embassy, John Hennessey-Niland, who both enjoyed the evening of Irish Shindig.

The conference fee was 550 Euro with the early bird fee of 495 Euro until December 31 and 525 Euro until January 31. A group discount of 495 Euro for clubs with 4 or more full participants was also offered. There were 120 delegates and 50 guests from 41 clubs. Sponsors included Presenting Sponsor US Tax & Financials, Clements International , KPMG and National Tourist Board. With generous sponsorship and strict budget controls, the Conference had a surplus which has been set aside by the FAWCO Board to contribute to future conferences.

The FAWCO Board of Representatives voted to make a change to the FAWCO By-Laws as follows “*The amount of the annual dues to be paid by member clubs may be reviewed and changed by a vote at the Biennial Conference or Interim Conference. All dues shall be payable by last the day of February.*”

Our wide range of interests were highlighted by a fascinating selection of conference speakers.. Dr. Mary Henry, a former Irish Senator, spoke eloquently about women’s health issues, including alcoholism, smoking, and obesity. Dr. Pat Wallace, Director of the National Museum of Ireland for 28 years and a world expert on Viking archeology, gave an entertaining speech over dinner in the beautiful Dublin Castle. A panel discussion entitled *Stop the Violence: Ireland*, moderated by journalist Susan McKay, included inspiring women whose work in rape crisis centers, battered women’s shelters, academics and legislation, opened our eyes to challenges and successes in addressing the issue of “Violence Against Women” in Ireland. Sarah Franklyn, Co-Founder and Director of Natural Capital Services, provided yet another viewpoint to “water sustainability” – tying water to trees and agriculture and stressing how important it is that solutions are comprehensive.

Besides evening entertainment of music and dancing, other introductions to Irish culture included a journey through Irish art history from Dr. Barbara Dawson of the Hugh Lane Gallery and a view into the Women of the 1911 Census from Catriona Crowe of the National Archives of Ireland.

We also had workshops from FAWCO’s Global Issues Task Forces. The Education Task Force had two workshops: Co-Chair Elinor LeBaron (AWA Qatar) presented *Americana*, a fantastic program to teach third-culture kids about American culture, and Co-Chair Susan van Alsenoy (AWC Antwerp) presented *No Excuses! Breaking down barriers that surround the education of learning differently for people at home & abroad*. On behalf of the Sharing Cultures Task Force, Robin Goldsby (AIWC Cologne) conducted a workshop on creative writing as a way to chase away our expat blues.

In 2012, FAWCO celebrated the 15th anniversary of its status as an UN accredited NGO with ECOSOC status. To mark the occasion, Peggy Rigaud (FAWCO First Vice President 1993-95, AWG-Languedoc Roussillon) was invited to share the history of FAWCO and the UN. Peggy was awarded FAWCO’s highest distinction the Circle of Honor award for her efforts in spearheading and completing this laborious accreditation process. Pam Perraud (FAWCO NGO Director, AAWE Paris) then continued with her session *FAWCO on the World Stage*, highlighting FAWCO’s involvement at the UN and how individual clubs can get involved.

US Liaison Lucy Laederich (AAWE Paris), along with Voting from Overseas Chair Mary Stewart Burgher (AWC Denmark) and new US Tax & Banking Co-Chair Margaret Spethmann (AWC Hamburg), shared new information on issues of concern to Americans living and working overseas. US taxes then got a special focus in another workshop from the Conference’s Presenting Sponsor US Tax & Financials. Both sessions were much appreciated by the delegates trying to help their club members navigate the increasingly complicated requirements.

The FAWCO Club Presidents had a working session with Club Presidents’ Coordinator Leslie Collingridge on *The 3Ss – Club Development for the Future*, brainstorming on how FAWCO can assist clubs to be successful, strong and sustainable. Meanwhile, FAWCO representatives worked with 2nd Vice President Elizabeth Abbot on

Communications – what works? During the Best Practices Panel, delegates were introduced to the FAWCO's online best practices library and shared in a round table of Best Practices tips and resources. The *Face-2-Face* session continued to be helpful for first time attendees, giving delegates unfamiliar with FAWCO the opportunity to learn more about the different facets of FAWCO in a one-on-one environment.

The *Over the Rainbow* themed FAWCO Foundation dinner and auction on Friday night raised over \$30,000 in a few short hours - a portion of the money raised was donated to a local charity, Children's Sunshine Home, which offers support & respite for children with terminal illnesses. A new FAWCO Foundation Board (2012-13) was elected under the leadership of President Michele Hendrikse-Dubois (IWC Munich). FAWCO Nominating Committee Chair (Kathleen Simon, AWC Bern), Foundation Nominating Committee Chair (Melissa Mash, AW Surrey) and Resolutions & Recommendations Committee Chair (Laurie Richardson, AWA Vienna) were newly appointed.

Two beautiful exhibitions on **Water** provided a nice backdrop for the conference and fundraised for the Target Program at the same time. Eileen Green-Doyle (AWC Dublin) organized an exhibition of 140 photos of water, submitted by FAWCO members from around the world. These images were included in a photo book available for sale as the AWC Dublin fundraiser for the Target Program. In addition, Afsaneh (Sunny) Eades (NAC), a FAWCO Caroline Curtis Brown Spirit Award recipient, was invited to exhibit her water painting works. Sunny also donated a portion of her proceeds to the Target Program.

The Conference was “online” so that FAWCO members at home could enjoy it from the comfort of their computer. Most sessions were video-taped and posted the next day. Presentations and hand-outs were available for download. Photos were shared the same day.

2012 FAWCO Awards Presented at Conference:

FAWCO bestowed its highest distinction ***The Circle of Honor Award*** on **Peggy Rigaud (AWG-Languedoc Roussillon)** for her contribution in FAWCO becoming a United Nations (UN) accredited non-governmental organization (NGO) with consultative status to the Economic and Social Council (ECOSOC).

The ***Caroline Curtis Brown Spirit Award*** was established in 2005 in appreciation of service exemplifying the spirit, inspiration and dedication of our Founder Caroline Curtis Brown. FAWCO applauded 2012 recipient is **Melissa Mash (AW Surrey)** for her dedication to volunteerism in both her own club and within FAWCO, and always with a smile.

The ***FAWCO Rep Appreciation Award*** was initiated in 2008 to recognize ongoing commitment, dedication and achievement of FAWCO Reps in member clubs. This year four FAWCO Reps received this honor: Alma Lou Annab (AW Amman), Clydette DeGroot (AWG Paris), Robin Meloy Goldsby (AIWC Cologne) and Donna Haas (AWA Dubai).

On behalf of the FAWCO Board, I would like to thank host club AWC Dublin, Conference Co-Chairs Patti Meek and Nancy Ward and their team of more than thirty volunteers for this nearly-perfect conference. We all left with new friends, a renewed sense of “FAWCO Fever,” and the inspiration, energy and empowerment needed to go forth and make a difference.

TARGET PROGRAM REPORT

While FAWCO's first Target Program officially ended on December 31, 2012, a few clubs are still planning fundraising events and donations will continue to be accepted until midyear 2013. In all, the Target Water Program has been very successful! At time of print, \$120,400 has been raised for Tabitha - *Wells for Clean Water* in Cambodia, resulting in 267 family wells and 310 field wells (but donations will be coming in for an additional month, so these numbers will increase). In addition, there are a number of clubs who for a variety of reasons, have donated to alternate water projects.

During the first year of the fundraising segment of the Target Program, focus was on engaging the clubs through awareness information, fundraising ideas and individual help. This was carried out through information in the *News in Brief* newsletters and a monthly Target Bulletin, as well as through individual email correspondence with reps. All these activities continued in the second and final year of Fundraising, and more in depth information on the importance of individual water use was given; a bit different from the general information that was more prevalent in the first year of the program. For those clubs that had been remarkably successful in their fundraising efforts the first year, this was a good way to keep them involved in the awareness aspect of the water issue, while raising funds took a "back seat." All awareness information was presented in the monthly Target Bulletins, which had 113 subscribers. While this is a respectable number, I always strived to increase subscription and often forwarded bulletins to reps and others who contacted me with questions. Reps were encouraged to "cut and paste" the awareness information and put it in their club newsletter.

A major focus for the second year of the Target fundraising efforts was to increase club participation. In May 2012, a personalized letter from me was sent to all the Regional Coordinators, as well as the 34 FAWCO reps of clubs which had not yet donated or participated in the Target Program. They were given brief information about the Target Program and encouraged to participate by making a donation to the Target (or other) water project, and/or by doing a water awareness event at their club. I offered to help in any way I could as well as put them in contact with an active "Target club" of similar size. A number of responses were received and a second letter was sent in September 2012 to the 27 remaining clubs not yet participating in *Target*. In this letter, links were provided to: 1) 2 PowerPoint presentations, 2) a list of seven easy water awareness ideas that could be used at their clubs, and 3) a list of fundraising ideas. The latest Target Bulletin was also forwarded via a second mail. While it is probably impossible to get 100% club participation, every effort has been made to encourage and help as many clubs as possible to participate in the Target Program.

Currently, information is being collected via a questionnaire to all FAWCO's clubs with six short (yes/no) questions regarding their Target participation. I will write the reps individually that I do not get a response from in an attempt to get as complete a picture as possible of clubs involvement in different aspects of the Target Program. This will also help me identify those clubs who donated to an alternate water project, so their donation totals can be included in our final Target numbers as well. A final report of the Target Water Program will be presented at the 2013 Conference in Bern.

The final aspect of the Target Program is its evaluation, so that problems encountered in this first Program can be remedied for the next Target Program. To that end, a Target Evaluation Task Force has been appointed by the FAWCO Board to review the entire process and to make recommendations (see report in Committees/Task Force section) concerning ways to improve the selection process and implementation of the next Target Program. This Task Force was chaired by 3rd VP Monica Jubayli, and as Target Chair, I have been actively involved along with Elsie Bose, Karen Lewis, Pam Perraud, Sara von Moos, and Tricia Saur. We look forward to helping create an even more successful Target Program #2!

UN NGO Director's Report

Special 15 Year UN NGO Review

After 15 years as a recognized NGO at the United Nations, it was felt that it was timely to conduct a special review of FAWCO's involvement at the United Nations. The report to the Board issued in May gave a brief history, reviewed the highlights of FAWCO's activities and gave recommendations on how FAWCO's efforts at the UN could be improved. Some of the key recommendations included:

- Adopting one “focus” for all of FAWCO’s UN and international projects which would clearly identify what FAWCO’s main area of interest is so that FAWCO could be classified, as all of the other NGO’s are.
- Adopting “women” as FAWCO’s primary “focus” or its over-reaching umbrella focus and “children, particularly girls” as the secondary focus of FAWCO’s international activities.
- Under the umbrella focus of women, organize FAWCO’s other areas of main interest under the following categories:

Human Rights - Working towards the ratification of CEDAW (Convention to End All Forms of Discrimination against Women) and CRC (Convention on the Rights of the Child) and to support efforts to protect women and children in conflict situations as well as to work for the elimination of violence against women and human trafficking.

Education - Promoting education and literacy for women and girls, supporting programs for dual national children as well as children who learn differently, and universal primary education.

Health - Supporting efforts to improve maternal health; access to information about reproductive and sexual health; promoting active aging as well as promoting awareness on substance abuse and other vital women’s health issues.

Environment - Supporting awareness programs on global warming and projects related to improving the world in which we live.

- Coordinating efforts of the NGO Team to work more closely with the Global Task Forces and the Foundation on the Development Grants.(DG’s)

Attendance at Meetings/ Conferences

New York UN NGO Rep Erica Higbie had a very busy year and attended over 40 meetings at UN HQ in NY. She is an active member of the CSW (Committee on the Status of Women) and the Working Group on Girls which meet monthly. She attended the annual CSW conference (Feb 27 – March 8) on the topic of Women’s Empowerment and Poverty Eradication for Rural Women as well as the pre-conference Forum. She attended many DPI briefings including “May I Ask a Question Mr. Under Secretary General” and was able to attend President Obama’s address to the General Assembly. As co-chair of the Violence Against Women and Children Task Force she has been particularly active in attending meetings this year at the UN on this topic.

Geneva UN NGO Representative Sara von Moos attended several meetings of the Human Rights Commission (HRC) in June and July including the “ HRC for Newcomers”, the annual full day discussion on women’s rights as well as sessions on CEDAW, “Stop Stoning Globally”, Harmful Practices against Women and Girls” and “International Women for Peace”.

In July, she attended a session on “Reproductive Health and Rights”. Sara also was in contact with UN Women Switzerland and attended several meetings to explore possible synergies between FAWCO and UN Women Switzerland. She also organized a tour of the US Mission at the UN in Geneva for the Bern conference as well as lining up several conference speakers with UN and NGO ties.

UN NGO Rep Paula Daepen, now member of the Bio Vision's Board of Directors, successfully helped BioVision apply for UN NGO recognition and ECOSOC. (BioVision was FAWCO's partner in its highly successful malaria Bed Nets initiative.) Paula also did a presentation on FAWCO's bed net program and malaria prevention for the Zurich International Women's Association.

Kathleen Simon attended a meeting of the Geneva CONGO committee in May and UN NGO Director, Pam Perraud attended several HRC side events in June which included sessions on "Addressing Violence Against Older Women," "Working on the Right to Peace", " Protecting Children during Conflict," " Empowering Young Women for Peace building", "the 2nd Cycle of UPR(Universal Periodic Review) for HRC."

Vienna

UN NGO Rep Laurie Richardson attended the March 8 International Women's Day Commemoration sponsored by the IAEA. She and Tonya Teichert attended the November 26 Symposium on Femicide at the UN in Vienna. Laurie also attends monthly meetings of the CSW. On UN Day, Oct 24, the AWA Vienna and the IWC Bratislava had a tour of the UN followed by a talk by experts from the UNODC on Human Trafficking.

Current UN NGO Projects

UN Women

As part of FAWCO's effort to participate more closely with the UN on specific activities related to women, in June FAWCO joined the UN Women National Committee of the United States. The UN NGO Director is participating in all of the regular Board calls with local chapters in the US and will be participating in regular UN Women activities going forward.

ERGLW

FAWCO continues to support the Eleanor Roosevelt Girls' Leadership Worldwide (ERGLW) and this year there was a bumper crop of daughters of FAWCO members who were chosen to participate in this highly select program. They were: Madison Stewart, daughter of Stephanie Stewart of Chilterns; Karin Hin, daughter of Marie Louise Cusack AAWE Paris; Julia Goldsby, daughter of Robin Goldsby of AIWC Cologne and Vasiliki Mitsakis, daughter of Alexandra Mitsakis from AWC Athens. Funding for this program last year was made possible by several generous donations by individuals and FAWCO clubs. It is hoped that the Foundation will add the ERGLW to its list of regular recipients for grants in the future.

16 Days Violence Against Women

This year for the first time, FAWCO participated in the UN endorsed 16 Days for the Elimination of Violence Against Women. FAWCO's Global Task Force encouraged local

clubs to have reading groups on "Half the Sky" a book by NY Times columnist Nicholas Kristof and Sheryl Wu Dunn. The book deals with violence against women as well as human trafficking and women's empowerment in the third world. The book was the basis of a documentary of the same name, sponsored by PBS and shown across the world. On Sept 17, UN NGO Director Pam Perraud and VAWAC Task Force member Therese Hartwell attended the screen in Houston where Sheryl Wu Dunn spoke about the book.

Education Task Force Report

Americana

This year AMERICANA (formerly ACE) is continuing programs for expatriate American children ages 3-10 "to ground [them] in the history and traditions of American life and culture." The files for Americana programs are now online and clubs are invited to use and adapt them as they see fit for the children of FAWCO clubs. Programs are continuing in both Doha and Dubai, a new program has been started at AWC The Hague, and at the Region 9 Conference in Doha, there was discussion of developing an Americana for Teens program.

College Guidance

As in the past several years, the Education Task Force updated and adapted a guide to the US university admissions process (prepared by AAWE Paris) to be posted on the FAWCO website. It also conducted a review of materials posted on the Education pages of the FAWCO website and deleted material which was out of date or no longer relevant. The Task Force hopes to post more articles pertaining to various aspects of education in the coming year

Students Who Learn Differently

Last year in Dublin, co-chair of the Educational Task Force, Susan van Alsenoy, debuted her recently published book, ***LEARNING WITHOUT BORDERS: Breaking Down Barriers that Surround the Education of Learning-Differently People at Home and Abroad***. It is an expansion and extension of the information found at <http://studentswholearn.fawco.org> and encompasses a more general audience, not just the expat community. Much of the new information is of value to students, anywhere in the world, LD or not. It is available on Amazon.com.

Ending Violence Against Women & Children Task Force Report

EVAWAC continued to evolve and grow during 2012, taking on new challenges and bringing clubs together to participate in global campaigns against violence against women. The Task Force produced four Bulletins, which we distributed via email to 112 subscribers; added 3 new resources to our website, including a high-level UN Report; continued to support the Americans Overseas Domestic Violence Crisis Center; led FAWCO's participation in the 16 Days of Activism against Gender Violence; and launched its involvement in Join Me on the Bridge in March 2013.

The Task Force is particularly proud of the fact that thirteen book groups from nine FAWCO clubs participated in the 16 Days of Activism Campaign between November 25th (International Day for the Elimination of Gender-Based Violence) and December 10th (Human Rights Day) by reading/viewing and discussing ***Half the Sky: Turning Oppression into Opportunity for Women Worldwide*** by Nicholas D Kristof and Sheryl WuDunn. It is hoped that this type of worldwide participation will continue in March for the Women for Women International's 3rd *Join Me on the Bridge* event. It is very encouraging that the Bern Conference delegates will participate and lead the FAWCO clubs in this activity.

We are also pleased to have completed a mission statement and new structure for our Task Force, which includes an executive committee that expands the potential for member participation. It is our objective to not only raise awareness about violence against women but to also encourage activism against it. Our coverage of the *VAW Act* and *End Trafficking in Government Act* while they were bills in the US Congress and the Girl Up campaign against child marriage were aimed at doing just that. Highlighting individual FAWCO members who are involved in the fight against violence to inspire others to act is another approach the Task Force is taking. In 2012 we reported on an AAWE Paris member who paints female victims of violence and our own co-chair's (Tonya Teichert) launch of a new website and movement: *Modern Abolitionists*.

The Task Force accomplished most of its goals but there is always more to do. Sharing Cultures will continue to promote the understanding and appreciation of cultures diversity through their efforts and with other FAWCO task forces.

U.S. LIAISON AND COMMITTEES' REPORTS

U.S Liaison's Report

The U.S. Liaison both represents FAWCO in Washington, reporting to the membership on recent and upcoming changes in legislation important to Americans abroad, and coordinates with other overseas advocacy organizations, particularly in organizing our annual Overseas Americans Week.

Over the past 2 years, FAWCO has continued to work with its traditional partners AARO, ACA and OVF. The “burning” issues continue to be *voting rights* and problems with *US taxes* and *banking*.

Voting Rights

In 2012, we partnered for the third time with Overseas Vote Foundation and offered our members a totally secure, dedicated *voter registration and ballot request website*. 724 people registered and requested ballots over the FAWCO-OVF website; half of them were voting either for the first time ever (6.4%) or for the first time abroad (43.9%) and almost one-third (32.6%) had never voted before moving abroad. The states in which they voted were those found in other voting surveys: in ascending order, FL, OH, VA, NJ, MA, PA, IL, NY, TX and CA.

In the spring, FAWCO and its partners learned, very late, of new wording required on the *Federal Post Card Application* (FPCA) regarding “intent to return” to one’s voting state and making no provision for young voters who have not yet established residency. In response to overseas concerns, the FVAP posted our preferred 2005 version of the FPCA alongside the 2011 version, and has contacted us all for comments on the new language they will propose in 2013.

The *Uniform Military and Overseas Voters Act* (UMOVA) has now been adopted in 10 states and the District of Columbia and was recently introduced in Missouri (not every state adopts it entirely; Utah, for example, did not include the language about young citizens abroad). In a number of cases, FAWCO has been asked for a letter in support of the law, to explain why it is important for the overseas community.

As representatives of UOCAVA voters, FAWCO and ACA both contributed to an *amicus* brief in connection with *Arizona v. The Inter Tribal Council of Arizona, Inc.* which focuses on the challenges posed by Arizona's Prop. 200 to voter registration by military members serving overseas, college students, and the elderly who, despite different reasons, all have difficulty in meeting the state's proposed voter ID law.

Overseas Americans Week

Given the election-conscious climate in Washington, we decided not to hold our usual “OAW” in 2012 but to be ready in early 2013 to introduce a much-changed Congress to the overseas community and some of its unique problems.

Meetings with the IRS – Treasury

In April and November, however, I met with number of senior officials of the IRS and Treasury Department alongside representatives of AARO, ACA, Democrats Abroad and Republicans Abroad. We spoke of the onerous FATCA reporting requirements, blocked access to financial services because foreign financial institutions (FFIs) are unwilling to pay the costs of meeting their own reporting requirements, US citizenship renunciations, and some financial and bureaucratic requirements difficult to honor when living in far-away places.

Already in 2011, in response to overseas concerns, the basic threshold for overseas filers had been raised from \$50,000 to \$200,000 for bona fide residents abroad. In November, we were gratified to see that more progress has been made: tracking of FFIs that, at least theoretically because of FATCA, are closing accounts held abroad by Americans; an ambitious drive to enter into intergovernmental agreements under which FFIs will report only certain types of accounts to their governments which, in turn, will report to the United States, rather than having the FFIs in direct contact with the IRS; eased regulations, like higher thresholds for reporting accounts or fewer years for which reporting is required, if the FFI can prove that accounts have not been denied to any U.S. citizens who are bona fide residents in the country in question; the possibility of an "advisory council" composed of representatives of overseas organizations to work with Treasury and the IRS in their ongoing process of refining and implementing FATCA regulations; identification of the tax-free foreign pension plans which will not be subject to FATCA reporting.

Maloney Bill on Overseas Issues

On August 1, HR 6263 was introduced in the House of Representatives calling for a *bipartisan federal commission* “to study the *impact of government policies on Americans living and working abroad* and to make recommendations to Congress to improve drafting and implementation of policies concerning the overseas population.”

The plan is to reintroduce that bill to coincide with Overseas Americans Week in February 2013 and to use that occasion to encourage more legislators to co-sponsor it.

In Conclusion...

2013 promises to be an eventful year, as Congress tackles tax legislation and looks for new sources of revenue. It will be essential for FAWCO members to watch for news on the website and through bulletins and be ready to act together when the time comes. *One great initiative stands out* in relation to the 2012 Maloney bill: AIWC Cologne drafted a letter in support of then-HR6263 and circulated a petition among their membership. The letter and signed petition were then sent to Congresswoman Maloney, all members of the Americans Abroad Caucus and the Congresspersons of every club member who had signed the petition. Bravo to *AIWC Cologne!*

Although the overwhelming majority of US families living abroad face no difficulty transmitting their citizenship, many still do. FAWCO strives to help these US citizens who face hurdles that often seem insurmountable. The main task for 2012 was updating the FAWCO Citizenship page, keeping it relevant for all members.

U.S. Tax and Banking Committee Report

After a successful introduction of the subject of Tax and Banking Compliance at the Dublin Conference in March 2012, the U.S. Tax and Banking Committee, in cooperation with FAWCO’s Platinum Partner, US Tax and Financial Services, continued the momentum by organizing informational sessions and presentations in Stockholm, Bern, Munich, Antwerp, Paris, West Midlands, and Doha, with more planned in 2013 for Dusseldorf, Rome and Cologne. The webpages have been updated with videos, handouts and suggestions for structuring local seminars so that FAWCO members can have electronic access to this important information.

The T&B Committee put out a May Bulletin detailing filing obligations and introducing banking issues and links. The October Bulletin focused on the New IRS web links and Cross Border Estate Planning issues. Although Eric Way, Co-Chair, stepped down, he continues to remain as an active member of the Committee. This means that the T&B Committee is looking for a volunteer to take on the Co-Chair position. Two FAWCO members in Germany have offered help as committee members but not as Co-Chair: one for legal issues, one for details on tax code changes and updating.

There has been quite a bit of correspondence with individual members regarding specific banking issues and tax questions regarding their particular situation. The T&B Committee provides emotional support and encouragement, FAWCO Lists, links to helpful information, perspectives on how others are handling the issue, and suggests “Go To” banks, where available. Members are ALWAYS encouraged to seek professional help and to report to the federal authorities! The main focus of the T&B Committee is on reduction of the **fear factor**.

Committee goals for 2013 are to reorganize the links and information on the T&B webpages so that they are searchable by topic, to expand information resources, to set up a blog, and to get a few other committee members responsible for updating content by subject/topic. Co-Chair, Margaret Spethmann, plans to attend Overseas Americans Week in Washington, DC in the second week of February. Assisting Clubs on how to organize and implement Tax and Banking Seminar offerings continues to be an additional priority.

U.S. Voting from Overseas Committee Report

With the support of the FAWCO Board, the web team and US Liaison Lucy Laederich, FAWCO continued to offer a dedicated website for voter registration and assistance (<https://fawco.overseasvotefoundation.org/vote/home.htm>), supported by our partner the Overseas Vote Foundation (OVF). OVF staff provided welcome advice and support throughout the election year.

The Committee is comprised of FAWCO reps and voting enthusiasts from a range of FAWCO clubs, but coverage is far from complete and still needs to be improved. The Committee Chair sent monthly messages about registration and voting to the Committee throughout the 2012 campaign, and the web team featured the announcements on the FAWCO home page as well as supports the Committee’s pages (many thanks to 1st VP Michele Wirt and her web team!).

The Committee Chair joined OVF and other partners in commenting on the Federal Voting Assistance Program’s (FVAP’s) revision of the Federal Postcard Application (FPCA), and urged Committee members to do so. Their recommendation called on FVAP to return to the old wording of Part 1, as the new wording both excludes voters born overseas and is confusing in general. The chair also took OVF’s post-election survey and urged Committee members to do so as well.

ADMINISTRATIVE COMMITTEES

Archives Committee Report

For some time now, FAWCO's Archives have been looked at with special interest, as many of us are concerned about their future availability to FAWCO members, as well as how best to preserve them. The technical possibilities are enormous and are discussed below. To begin with though, let us consider the importance of the Archives and what they mean to FAWCO.

Starting with 9 clubs in 1931, after 82 years there are now 73 FAWCO Clubs. All were situated in Europe at the beginning; they now exist on all continents. Although world-wide, at no time has there been a "Headquarters" –the closest to one is where the current president keeps her files and computer! Therefore, there is no central place to store all material and documents about FAWCO's past, except in the Archives. We all agree: the heart of FAWCO – i.e. what has been studied and what has been accomplished, deserves to be recorded and preserved for posterity. Much of it needs to exist in its original state, namely original and hard copies, including documents. That's where the "we" of the Archives Committee come in. After having had only a few "homes", meaning under the careful aegis of a handful of dedicated FAWCO women, they have been happily stored and tended in the cellar of the AWC of Zürich for over 12 years. Alas, the state of the room has deteriorated by dampness, and it is necessary to seek a new home. At the same time, the possibilities offered by electronic preservation are being investigated by professionally savvy FAWCOites so that already now, access to much of the material is available.

There is though, a lot more. Besides conference minutes, there are club constitutions, committee reports, studies, photographs, speeches, official letters – including from First Ladies referring to our conferences – plus club news, memorabilia and reports on what we have accomplished for Americans abroad. Newspaper clippings referring to our work are especially impressive – including ones from as early as 1932!

Because there is constant change in club membership, Board, Reps, etc., we need the Archives to record what we cared about and what our new interests are, and how we tackled them. It sums up what FAWCO was and is about. They record the friendships we have made with other clubs all over the world. Most important, they keep our history alive and thereby honor all those women who have been – and are being – inspired by FAWCO's mission, and who worked – and work today – to bring it to fruition.

In June 2012, the **Archives for the Future Committee** submitted a Report to the FAWCO Board recommending how Archives would be best treated and stored for the future. This Report sets out the recommendations and current status.

All printed Archives are currently gathered at the home of Emily van Eerten (AWC The Hague) except some specific financial records. These financial documents are being stored in the home of Julie van der Wolf in The Hague and include Financial Audits and Correspondence 1968-1985; Audits 1983-2001, Bank Records, receipts (old), FAWCO Conference Reports 1933 – 1988; Slides; and Framed photos.

1. The Archives for the Future Committee is in favor of moving toward electronic storage but there are important **original documents and Conference material** that the Committee would like to see remain **stored in printed format**. The FAWCO Board accepted this recommendation and agreed that *all legal corporate obligations and information of historic or potential historic interest for FAWCO* are to be kept in printed form. Also, each *Conference Annual Report, Conference Directory, Conference Agenda, approved Conference Minutes, Financial Report as presented at conference and letters from the US First Lady* are to be held in archives in printed form. If a document is irreplaceable then the committee suggests it is returned to storage rather than being thrown away. The FAWCO Board is deeply grateful to AWC Zürich for housing paper archives over this past decade. The storage area was becoming damp, however, and AWC Zürich recommended in the summer of 2012 that FAWCO find another home for archives. These original documents and conference material still need to be stored and the FAWCO Board asks if a club or individual are prepared to house paper archives.

2. The Committee recommended **scanning all important Archive material** to ensure posterity of this valuable resource and accessibility for membership. So in September 2012, Emily van Eerten collected all printed archives from AWC Zürich clubhouse and drove them to her home in The Hague to initiate scanning. Jackie Isler (AWC Zürich) retained a few scrapbooks to bring to Bern which Emily will take home after the Conference. Kathleen Simon (AWC Bern) gave Emily two Western Digital My Book Hard Drives to be the permanent "home" of the digital archives. Member clubs' electronic storage space is estimated at: copy of their Statutes is 18.8 KB, FAWCO membership application 56 KB and a typical Club Profile 56 KB totally 131 KB per club x 75 clubs =9825 KB =0.01 Gigabytes. As a minimum club requirement, this figure gives us some idea of how much storage space is needed.
3. Once we place Archives on a hard drive we will then generate more space for **member club information to be stored electronically**. The Committee recommended that the FAWCO 2nd VP for Member Clubs is sent specific material from all member clubs in electronic form. The 2nd VP would then forward the details on to the Board Secretary by 30th September each year. The Committee recommends collecting: clubs' current Bylaws or any other governing document confirming official status; invitations, announcements/photos from special events such as club anniversaries; one copy of a club newsletter per year; an annual report if published and their extended FAWCO Club Profile.
4. Emily van Eerten, as custodian of the Archives, has agreed to temporarily chair the Archives Committee until another chair is found. Our sincerest thanks go to Jackie Isler for her many years of safeguarding the FAWCO Archives.
5. The Committee recommended that all material on the FAWCO **website** be backed up and archived electronically. Cat Conner, FAWCO Web Manager reported that our website is currently backed up twice per week, once by our service provider and once by the Web Manager scripts. *Note:* the backup does not affect anything inside the system which contains all FAWCO Newsletters.
6. The Committee specifically recommends that the FAWCO Board Secretary is sent all important documents (e-bulletins, Connections, etc.) to be uploaded onto an external hard drive for which she would be personally responsible. The Committee agrees with the Web Manager's suggestion that FAWCO should separate any workflow with the Board Secretary to that of any backup on the website. One big advantage of the secretary/archiver model is that there are only two people officially responsible for checking and monitoring document entry. As this is an enhancement of her role, we hope that the Web Manager might give her, if necessary, a tutorial on how to upload documents to an external hard drive.
7. The FAWCO Board has defined specific material to be held by FAWCO Archives **annotated according to the officer responsible**. Each officer should ensure that the material reaches the Board Secretary who will hold the external hard drive.
8. Once these recommendations are approved, it is important that they are enforced, and each officer or person sends their documents to the Board Secretary. We suggest that procedures are, therefore, added to the FAWCO **Administrative Guidelines under Officers' Responsibilities**.
9. The Committee has asked that the Board develop a **policy and disclaimer for permission to display archival material (including photos)** on the FAWCO **website**.
10. The Committee recommends that the **Archives Committee Chair** has authority to ensure that required material is submitted for preservation in the Archives (whether print or digital).
11. To ensure that the **Secretary's external hard drive is backed-up**, we ask that all **Officers retain original documents** as well as the work of US Liaison, NGO Director, Task Force and Committee Chairs
12. The Committee also recommends that the Board explore procedures for **backing up electronic Archives** in addition to the external hard drive of the Board Secretary.

By-laws and Administrative Guidelines Committee

It is the responsibility of the Bylaws & Administrative Guidelines Committee to process all proposed amendments to the Bylaws, advising as to their relevance, helping with the drafting and assuring timely circulation to the member clubs before the vote at the Conference. When an amendment has been accepted, this committee must provide an updated copy to the FAWCO treasurer for filing with the Internal Revenue Service (IRS) and updated copies for a general FAWCO mailing.

By-Laws

At the 2012 Interim Conference in Dublin, the FAWCO Board of Representatives voted to make a change to the FAWCO By-Laws in Article XIV – Financial Administration. Sec 2. Financial Support as follows “*The amount of the annual dues to be paid by member clubs may be reviewed and changed by a vote at the Biennial Conference or Interim Conference. All dues shall be payable by last the day of February.*” (adding “and Interim Conference”).

Reason for change:

After a careful analysis of FAWCO’s dues structure, it was determined that from 2000-2011 FAWCO lost approximately \$14,000 due to currency exchange. This loss was due to three factors: the average exchange rate per year from 2000 through 2011 reflected a 37% decrease in the U.S. dollar over the Euro. Most of FAWCO’s dues are received in U.S. dollars, while most of the expenses are paid in Euros. Expenses have gone up over the past 11 years, while dues have remained the same. Due to these fluctuations in the exchange rate, it has been deemed necessary to review the amount of annual dues yearly instead of biennially.

Administrative Guidelines

Over the past 2 years, the FAWCO Board streamlined the Administrative Guidelines significantly removing whole sections to form separate documents as these sections were deemed too detailed to be in the AGs. The sections relating to the Committees’ and Task Forces’ responsibilities formed the Handbook for FAWCO Administrative Committees, Handbook for FAWCO U.S. Issues Committees, Handbook for FAWCO Global Task Forces, and Handbook for FAWCO Target Program. The sections on responsibilities of the Regional Coordinator and the FAWCO Rep formed separate documents, as well as the Communication Guidelines. The updated Administrative Guidelines and related Administrative documents were posted on the FAWCO Website in October 2012 under About FAWCO/Admin Documents.

Membership Committee Report

The Membership Committee is responsible for assisting applicants in applying for FAWCO club membership, providing prospective clubs with FAWCO information and recruiting new clubs.

After many successful years recruiting new FAWCO members clubs, we have experienced nine resignations in 2012.

Bordeaux Women's Club joined FAWCO in March 2012, but decided not to renew their 2013 membership. The other clubs submitting their resignations are: AW Amman, Thames Valley, Women's Association of Egypt, Madrid International Newcomers Club, St. John's Wood Women's Club, American Club of Hertfordshire, AWC Aarhus and the American Women's Auxilliary for the Royal Children's Hospital of Melbourne.

Maintaining membership and recruiting are both important for the future FAWCO. The Membership Committee has been active in recruiting by sending nineteen introductory emails to potential member clubs. Many expressed interest in FAWCO, but informed us that they will not apply for membership at this time.

A meeting with the new FAWCO Board to discuss a new recruitment strategy plan is a top priority. FAWCO recruitment is most effective through word of mouth and personal recommendations from FAWCO member clubs, so we plan to contact Regional Coordinators to help us identify American and International organizations in their regions.

My-Linh has demonstrated a deep sense of accountability, high commitment to performance and respect for her team members. My-Linh has the skills, diplomacy and brains that it takes to guide her team and to coordinate with our related organizations all those functions that FAWCO is known the world over for: serving our member clubs, embracing our important position at the UN as a recognized NGO, blowing our trumpet in Washington and fundraising for life giving issues.

In setting out her vision for the next two years, My-Linh believes "FAWCO is a credible and formidable resource in US Issues and I would like to see FAWCO taking a more active part in global women issues. I believe we could leverage our UN connection more to make an even bigger difference through our Target Program and global awareness raising initiatives through the Task Forces. Monica graduated with a double major in History and Geography from the University of California, Davis. In 1972 she spent one year abroad at the American University of Beirut (AUB) in Lebanon studying Ancient History and Archaeology. Forty years later, she is still in the Middle East, having married a Lebanese graduate student in 1974. They have four adult children all over the globe. Monica earned a Masters in Education (Teaching English as a Foreign Language) at the AUB and continued to teach throughout the years, from middle school to university. Since 2001 she has been teaching scuba diving and is an IANTD Instructor Trainer. She has been the President of AWC Lebanon and upon her move to Dubai, brought AWA Dubai back to FAWCO and has served as their FAWCO Rep. Monica has attended every FAWCO conference since 2007 in Lyon.

More recently, Sallie served as a member on the 2011-2012 FAWCO Foundation Nominations Committee. Resolutions and Recommendations 2013 – 2015

FAWCO Resolutions & Recommendations are adopted at Biennial Conferences to serve as guidelines for FAWCO and Member Club action for the next two-year term. They reflect FAWCO's commitment to women's rights, concerns of overseas Americans, and a better and more peaceful world.

1. Resolved: To improve the lives of women and girls worldwide, especially in the areas of human rights, health, education and environment.

Recommended:

- 1.1 Promote the United Nations Millennium Development Goals, particularly those that address women's issues.
- 1.2 Increase FAWCO's engagement as an accredited UN NGO by working on global women's issues with UN Women and the UN NGO Committee on the Status of Women, and encouraging club events to celebrate International Women's Day each year.
- 1.3 Focus Global Task Force efforts on ending violence against women, improving women's health, promoting equal access to education for women and girls, and encouraging active aging for women.
- 1.4 Establish criteria to ensure that the next cycle of the Target Program explicitly improves the lives of women.
- 1.5 Campaign for ratification by the US Congress of the United Nations Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW).

2. Resolved: To advocate for the rights of American citizens living and working overseas.

Recommended:

- 2.1 Serve as a recognized voice in Washington, DC for overseas Americans; work with the Americans Abroad Caucus in the US Congress, the Departments of State, Treasury and Defense, and partner organizations to shape US legislation and regulations that address the special needs of Americans living abroad, including voting rights, citizenship rights, taxation and banking.
- 2.2 Provide tools and information to empower overseas Americans to more effectively manage the tax, banking and legal complexities of their overseas lives.
- 2.3 Disseminate overseas voter registration information, promote and facilitate voting from overseas, and encourage active citizenship.
- 2.4 Keep FAWCO members informed about issues arising in the US that can have an impact on Americans living and working overseas.
- 2.5 Advocate for more effective representation in Washington for US citizens overseas.
- 2.6 Contribute to efforts to obtain reliable statistics on Americans overseas.

3. Resolved: To support member club success by strengthening the FAWCO network and expanding access to ideas, information and club development resources.

Recommended:

- 3.1 Provide opportunities for member club presidents and FAWCO representatives to exchange ideas, information and resources, share best practices, and learn from one another's experiences in order to develop and sustain more successful clubs.
- 3.2 Improve the user-friendliness of the FAWCO's website, making it more attractive, informative and useful to member clubs and other women living overseas.
- 3.3 Stay abreast of the latest available technologies to facilitate communication and promote FAWCO programs.

3.4 Encourage more active participation of member clubs in conferences, regional meetings and FAWCO committees.

3.5 Strengthen the FAWCO network by attracting new member clubs, both American and international.

4. Resolved: To contribute to a better and more peaceful world by encouraging all members of FAWCO clubs to practice good global citizenship.

Recommended:

4.1 Promote opportunities for member clubs to get involved in FAWCO's work on global issues and philanthropy.

4.2 Champion the role of the UN in promoting world peace and improving lives; raise awareness of the work of the UN and encourage member clubs to observe UN Day each year.

4.3 Promote cross-cultural understanding and respect for international perspectives through FAWCO's Sharing Cultures Global Task Force, and at conferences and meetings; encourage member clubs to participate actively in their communities and collaborate with other international organizations.

4.4 Work to meet the educational needs of bi-cultural children and those who learn differently living overseas.

4.5 Encourage international members to stay informed about legislation in their home countries that affects their rights and responsibilities as overseas citizens.

4.6 Serve as models of environmental stewardship by taking steps to reduce the impact of climate change: recycle, reduce energy and water consumption, offset the impact of air travel, and adopt green measures in our daily lives.

Sites Selection Committee Report

The Sites Selection Committee is primarily responsible for finding sites for the FAWCO annual conferences and assisting conference chairs to complete a viable budget and get started with conference planning. The Committee's goals are four-fold:

1. Find sites for 2014 FAWCO Conference: After securing Bern as the host for the 2013 FAWCO conference our goal was then to find a host club for the 2014 conference. The FAWCO Board has accepted a bid and the announcement will be made at the Bern Conference. The chosen club continues to receive support and advice from the committee.
2. Support of the hosts of the future conferences: We have been in touch with clubs who would like to be future conference hosts answering their questions, working on budgets and giving advice.
3. Complete FAWCO Conference Planning Chart: The FAWCO Conference Planning Chart, a daunting compilation of statistics has been completed for Birmingham, Berlin, Lyon, Seoul, Vilnius, Boston, Marrakech and Dublin. This allows point by point comparison of the yearly conferences and will help future host clubs organize FAWCO Interim and Biennial conferences. In order to facilitate completing the statistics chart, The FAWCO Conference and Planning has been updated by adding a questionnaire for the conference planners as part of the post-conference report.
4. Solve Conference organizational difficulties: In general, the difficulties that each host club has faced in the past still plague current and future host clubs. The financial aspect and banking seem to be the largest obstacles.

“Gratefulness”, noun: acknowledgment of having received something good from another. The FAWCO Foundation has so many reasons to be grateful this year. From day one, last March, when the out-going Board passed on a healthy organization, to our always generous individual and club donors, to a current Board that works so well together and fantastic FAWCO and FAUSA boards to work with - we really are so very grateful for all we have received.

While there are positive signs of improvement, world economies continue to struggle and real significant improvements are slow to arrive. However, FAWCO member clubs, FAUSA and individual supporters are giving as generously as always. Our net income showed an increase of \$37,131 over 2011. We offer a HUGE Thank You to everyone who supports The FAWCO Foundation’s programs!

Fundraising will always be a challenge as clubs have limited budgets and must choose between local projects, the FAWCO Target Project and Foundation programs. However, results from the survey The FAWCO Foundation initiated in December 2012 show that our Education Award and Development Grant programs as well as the FAWCO Target Project are still very important to the clubs and our individual supporters. We are encouraged by the survey results and look forward to continuing to offer the programs you all hold dear to your hearts.

The Foundation Board had a unique challenge this year as we were only elected for a one-year term. The shortened term made setting goals and implementing projects more difficult. We went into the year knowing most progress would be in planning so projects could be moved forward quickly in the next two-year term. As president, my four goals for our term were to:

1. Review TFF’s Endowment Fund, clarify the description and details of the fund and to create a written record of the fund details.
2. Review the reimbursement policy for TFF Board expenses and move toward greater reimbursements for Board expenses.
3. Look at the idea of sponsorship/grants as a source of income.
4. Survey the clubs to ensure TFF continues to provide the programs the Clubs desire.

Carol McEowan, member of the AWC Bern, says that the award was hugely responsible for making her recent journey successful - not just the financials but the support she got from her friends to apply in the first place. She worked 60 percent while completing two college courses (each consisting of 300 hours of coursework). She continues to teach English, do translations for friends and long-term clients and is mother to two teenagers. The award helped her maintain her motivation. She has bettered her German and realized how energy efficiency and sustainable energy policies can effect positive change at all levels of society and throughout the world. She also says that her kids now see more clearly the role we each have in society and in the larger world.

We wish to thank Carmen Clarke for reviewing the Awards forms, suggesting and implementing program improvements and overseeing the 2013 Awards Committee. Carmen dedicated a great deal of time to updating the Awards forms and making them more user friendly while continuing to streamline the process that was started the previous year.

NEEED SCHOLARSHIPS

NEEED is a program based in Burkina Faso to provide post-secondary education studies for girls in the fields of primary school teacher training, nursing, midwifery and university studies. In 2012, Porgo Mariame, Mariétou Ouédraogo, and Risnata Nacanabo received their teacher training diplomas. Eugenie Ouedraogo and Rasmata Nadziga graduated from their two-year nursing training programs. Clementine Sebgo finished her first of two years in nursing training and Alima Ouedraogo finished her second of three years in midwifery training. Our 2012 donation will fund the education and housing of two girls for a two-year nursing program and one girl for a two-year primary teacher training program.

A donation has been made to The Foundation for a 5-year commitment to provide one 3-year midwife training scholarship per year. In addition, a donation for a two-year scholarship for one girl to study as a primary school teacher has been made directly to NEEED in the name of FAWCO. This donation will apply to the 2013 scholarships. We continue to collect donations for this program and look forward to offering more girls from Burkina Faso a chance at higher-education.

FUNDRAISING

To carry out FAWCO programs, we rely on FAWCO clubs and members (please see donor list). Any shortfalls in financing are covered by The FAWCO Foundation, which it must be pointed out, does NOT receive any monies through grants or corporate sponsorship at this time. The primary sources of funding are through club/individual donations and money raised during Foundation night at annual conferences. In 2012, in addition to donors' generous support and funding of Awards, DGs, and NEEED scholarships, VP Fundraiser, Suzanne Wheeler, brought in \$50,000 towards specific programs.

Dublin's Foundation Night was a huge success thanks to the generosity of our donors. This conference introduced the idea of a high-end raffle item in addition to the ever popular Friendship Quilt raffle. The raffled emerald ring raised \$5086.78. Many silent and live auction items combined with a large participatory audience resulted in the

evening raising over \$36,000. We wish to thank all those volunteers who helped in setting up the Silent Auction and decorating the ballroom. You know who you are and we thank you!

Continuing with the charm bracelets first offered in Vilnius in 2009, a lucky clover charm was available in Dublin. Charms sold in Dublin raised \$2,897. Ann De Simoni, has procured another beautiful charm for Bern. The Board also decided to sell complete charm bracelets with all the existing charms to clubs for club fundraisers. Two bracelets have been sold. In Bern, we will sell the remaining complete bracelets to attendees.

Every year since 1995, FAWCO members throughout the world have contributed their creativity and sewing talents to the FAWCO Friendship Quilt. The 2012 quilt included 70 handmade quilt squares floating on the waves of the "sweet water" quilt - 100 rivers were represented. The quilt raffle raised \$4,453.22. Sue Elliot from AWC Dublin was the winner. Roberta Zollner along with 53 individuals from 26 different clubs, contributed to this wonderful quilt. The 2013 quilt "Time" is another beautiful piece she has created using over 54 blocks from 18 clubs made by more than 25 participants. This fabulous product has become a much anticipated tradition every year. Heartfelt thanks to all who contributed, in particular Roberta for her wonderful creations.

The iGive program continues to provide a small income derived from members using the link to purchase merchandise and services over the internet. In 2012, we received \$524 from iGive.

It is worth noting that all donations made to The Foundation are tax deductible on US taxes, as allowed by law. For donations under \$250, no receipt is needed. For online donations, a receipt is sent to the email address provided to PayPal at the time of donation. For donations at the Conference, we have postcards printed for anyone who wishes a hard copy receipt. It includes our EIN which is 43 607 5073.

FAWCO TARGET WATER PROJECT

2012 brought an end to the FAWCO Target Water Project. The \$80,000 target (to celebrate the 80th anniversary of FAWCO) set in Marrakech, was surpassed in 2011. While the project has officially ended, there are a few final club fundraisers planned so donations continue to flow in. Donations in 2012 totaled \$44,316. As of the end of 2012, the total donations to the FAWCO Water Project were \$120,400. TFF Treasurer, Kathy Coughlan, made quarterly payments to Tabitha through Dec, 2012; she will make a payment in January and a final payment once a few known 1st quarter 2013 donations are in. Thank you to everyone who participated in this very successful program!

COMMUNICATIONS

Our VP Communications, Cynthia Smith-Ayed is responsible for our website and lines of communication open to our members as well as the public. This year we signed up for the archives feature in the Constant Contact account so that the *News You Can Use* newsletter can be put on the website after publication as a resource.

The Foundation is on Twitter and Facebook (where there is a permanent "like" button on the homepage) allowing people to share Foundation information with their friends. There are buttons on the bottom of each web page which allow readers to sign up for *News You Can Use (NYCU)*, our matching gift program, Facebook and "Make a Gift, Make a Difference" donations.

The website has been updated and corrections are being made with assistance from other Foundation Board members. Cynthia worked with Cat, the FAWCO web woman to set up an RSS-feed so that new items on the website will go directly to the Facebook page as well.

Our newsletter, NYCU, is emailed to some 200 contacts monthly. NYCU speaks directly to Club presidents, FAWCO reps and donors about fundraising events, Foundation initiatives and what they can do to support The Foundation.

The homepage of the website is updated regularly with project stories, Development Grant and Education Award information and upcoming/current events. The Target project information was updated as donations were received and donors posted on the 'Well Wall'. Requests from club members to add or edit information are also given consideration. We continue to increase the use of photos and personal stories to help promote The Foundation and help make people feel a part of all the wonderful things The FAWCO Foundation does.

ALIGNING BOARD ELECTIONS

At the Dublin Conference, The FAWCO Foundation Board was elected for a special one-year term allowing for the alignment of The FAWCO Foundation and FAWCO Boards. In March 2013 two independent boards will be elected to serve from 2013-2015.

FINANCIAL REPORT

Please see Kathy Coughlan's Treasurer's Report below. Over the summer, Kathy repatriated and is now living in the US. The Board decided it was no longer necessary to appoint an Assistant Treasurer as the main function of that role was to manage US dollar transactions which Kathy can now handle on her own.

ADMINISTRATION

Our Secretary, Margaret Hilditch, took on the additional task this year of coordinating The FAWCO Foundation Survey. She worked closely with FAWCO President, My-Linh, who generously offered to help with the survey including the survey set-up and use of FAWCO's Constant Contact account. Margaret worked through several drafts and re-writes and sent the survey to Friends of the Foundation, FAWCO and Foundation Counselors, FAWCO member club Presidents and Reps. She was also instrumental in compiling the results. Speaking of instrumental, Margaret is coordinating the music for Bern's Foundation Night including the creative re-write of special lyrics for our enjoyment.

I want to thank the FAWCO Board for their support over the past year. I attended most of the FAWCO Board meetings including their 3-day on-site meeting. Cynthia, The Foundation's 1st VP, attended the meetings I could not attend. My-Linh or Elizabeth, FAWCO 1st VP, attended all of TFF meetings including our 2-day on-site meeting. The cooperation between the two Boards is strong and growing. There is a very positive energy shared between the two Boards. THE FAWCO FOUNDATION TREASURER'S REPORT 2012

Below are the 2012 financial statements for The FAWCO Foundation. Our financial year follows the calendar year and we have included the most recent financial year (not reviewed) and the prior year (with the associated accountant's review letter.)

Our financial position and net income substantially increased during 2012 as compared to 2011. The FAWCO Foundation was fortunate to receive a \$50,000 donation from Viola Wheeler to be used to fund the Art Award, NEEED scholarships and for general needs of the foundation. In addition, monies raised for The Target Water Project in 2012 were not remitted until 2013. This has overstated our financial position by \$11,000 as of year-end. This highlights that our financial statements are presented on a cash basis and as such we usually pay for grants and awards the year after receipt of the donation. The cash presentation is therefore not reflective of actual profits. Thus, the substantial increase in cash will not be sustained, as these monies will be paid out in future years.

Interest rates have been very poor over the last two years and that is reflected in a decrease in other income. Total income in 2012 decreased due to the decrease in donations for the Target Water Project as compared to 2011. This decrease was offset by the large donation made by Viola Wheeler and the continued generous Target Water Project donations that were received this year. Of course, Viola's donation will be used in future years while the Target Water Project contributions were sent to Tabitha in January 2013.

Expenses decreased due to the decrease in payments made to Tabitha, which corresponded to the decrease in cash receipts for the Target Program in 2012, as discussed above. We included in-kind donations by the Board for expenses in which no cash reimbursements were made. Amounts totaled \$3,677 in 2012 compared to \$3,643 in 2011. In-kind expenses are understated in both years as the Foundation Board still under-reports unpaid expenses. In addition, Paypal charges during 2012 were reported as fundraising expenses while in 2011 they were reported as contract services. Board expenses of \$6,211 in 2012 and \$4,505 in 2011 were reimbursed.

We have also included pie charts that show the sources of income and expenses for 2012. The 2012 income sources show that our income is supported by The FAWCO Foundation events, individuals and clubs, which is very appreciated.




**Task Force on Ending Violence Against Women and Children

FAUSA Alumnae USA (FAUSA) enjoyed yet another outstanding year as the third “sister” entity of the greater FAWCO organization. But first, a bit of FAUSA history.

Informally established in the late 1970s to encourage FAWCO club members repatriating to the US to keep in touch with one another and to assist them by giving them current information on various issues pertinent to adjusting to life back home, FAUSA eventually went on to become a 501(c)(4) not-for-profit corporation in the State of Texas. It celebrated its tenth anniversary as a corporation in 2010. Like The Foundation, FAUSA operates under its own bylaws, administrative guidelines, Board of Directors and financial responsibilities. Every Fall, we hold an Annual Getaway somewhere in North America, and we do not pay dues to FAWCO.

Despite our name, membership is not limited exclusively to previous, or current, members, of a FAWCO network member club. Although most of our members are alumnae of those clubs, we welcome others who have lived abroad, have a global perspective and a passion to do their part to change the world for the better through keeping apprised of world events, contributing to educational and philanthropic endeavors, and volunteering to work toward those aims. In short, we all speak the same “language” we learned by living outside our own countries’ borders.

The FAUSA Year

It has been a fine year for FAUSA. When the current board took office in October 2011 at our Annual Getaway in Charleston, S.C., we set several ambitious goals for ourselves. At last November’s meeting in Napa, CA, we were very happy to realize that we had not only accomplished those goals, but a few others as well. Communications have greatly improved with members through an improved website, more frequent and more informative Electronic Newsletters, a survey whose responses gave us new directions to follow, and the initiation of a virtual book club. New useful information and tabs are frequently being added to the website, and members are encouraged to write articles for publication, as well as their own stories recounting their experiences as an expat or re-pat. It was voted to resume publication, at least once a year, of the Highlights magazine, both as a source of information and useful articles and as a way to advertise who and what FAUSA is and does. The first issue is due for publication later this year.

Recently, in response to the tragedy that occurred in Sandy Hook, CN, within a few miles of the home of our 2nd VP-Membership, Janelle Mason, additional E-Newsletters have been sent urging members to write to the White House, their congressmen, senators, and the NRA asking for a plan to control the sale and use of weapons. Janelle has kept us informed of activities in Sandy Hook in the aftermath of the shootings. FAUSA will be making a contribution to the village when plans are announced. The gun issue is not a political issue but a safety issue; it is a matter of common sense to limit the sale and use of these weapons to protect the tens of thousands of victims, many women and children, who are murdered every year by them.

At the time of this writing, the 2013 membership campaign is still going on. We hope this year to surge ahead of the approximately 225 members, including spouses, that we have had for the past few years. We are striving to offer more and better to them, and we are succeeding. Our Regional and Metropolitan Coordinators have organized some outstanding, well-attended activities this past year and promise to continue to do so. Photos of events are posted monthly on the website and in the E-Newsletters.

Thanks to Erica Higbie, who volunteered at the Dublin Conference, we have a new committee entitled Repatriation.. She posts articles and other information, and recommends reading lists regarding adult issues of returning home, as well as for children whose problems, although they leave and return home as often as their parents, are usually overlooked. Erica also serves FAWCO as the New York Representative to the UN and as Co-Chair of the EVAWC Task Force.

Highlight of the year was the Annual Getaway held in November in Napa, CA, the center of the wine country. Reservations were anticipated for 35 members, partners and friends, and over 50 showed up! In addition to an outstanding social program and tours of local wineries organized by Janet Darrow-Winter, a very informative and fruitful business meeting was held. Three excellent speakers gave us valuable information about potential financial elder abuse, how to detect it and what to do; the effect of re-entry on children and adolescents and possible solutions to problems; and the shocking statistics regarding the number of American women married to foreign nationals who are abused, along with their children, and their helplessness in the face of it. Paula Lucas, FAUSA member, spoke movingly of particular cases of women and children her organization, American Overseas Domestic Violence Crisis Center, has helped in the past and her plans for the future expansion of the organization. A memorable conclusion for some at the meeting was a spectacular hot air balloon ride over the many square miles of verdant vines, topped off by a gourmet champagne breakfast at one of the wineries.

Plans are now underway for this year's Getaway, which will be held in Cincinnati, Ohio.

FAWCO and the FAWCO Foundation

During the four decades of its existence, before and after incorporation, FAUSA has maintained a close relationship with FAWCO and The FAWCO Foundation (TFF). For the second year, FAUSA members contributed enough funds to fully sponsor the Members Award for Continuing Education and to co-sponsor with the family of FAUSA Counselor Louise Greeley-Copley the Right to Food and Water Development Grant. Thanks to the generous donation of a member couple and the matching funds program of his company, we are able to ensure our sponsorship of these awards again next year. We also contributed again to the Eleanor Roosevelt Girls' Leadership Worldwide program, as well as the Target Water Project, which was nominated by our own 1st VP-Communication and PR, Yolanda Henry. At the Napa Annual Getaway, enough funds were raised also to support member Paula Lucas' Americans Overseas Domestic Violence Crisis Center. A large percentage of the total came from the raffle of yet another gorgeous quilt created by Kay Miller, FAWCO Counselor.

Also for the second year, FAUSA members and their children were eligible to apply for The FAWCO Foundation's Educational Awards, and we can nominate projects for DGs and the Target Program. Members who remain members of their overseas clubs are eligible to serve on The FAWCO Foundation board, with the exception of the positions of President and 1st VP, and we may serve as FAWCO committee/Task Force chairs, as well as members of them.

For the first time, FAUSA was invited to organize a workshop of interest to all FAWCO members at FAWCO's Biennial Conference in Bern. Judy Treanor and Ellen Mahoney, with contributions from Erica Higbie, will be doing a presentation entitled "Families in Transition: Abroad and Home Again – Issues around how women and children experience reverse culture shock and some coping strategies to minimize its impact. They will discuss, and offer some solutions to, issues that most FAWCO club members will have to confront at one time or another, whether or not they currently think so. It sometimes happens that we must return "home" unexpectedly, which compounds the shock of re-entry. FAUSA can serve a valuable and effective role in lessening that shock and help resolve some of the practical problems that arise by giving access to individuals and information available at a click of the mouse or by phone. It also provides a ready-made circle of friends who understand.

A new initiative taken by the current FAWCO President, My-Linh Kunst, is a long-awaited joint meeting in Bern of the presidents of the 3 sister organizations, FAWCO, The Foundation and FAUSA to discuss issues of mutual interest and to share ideas about their own and the other organizations.

In 2000, FAUSA organized and sponsored the first FAWCO Conference held in North America, in Washington, D.C., and the second in Boston in 2010. It was decided jointly by the boards of FAWCO and FAUSA that every decade in the future the conference would be held in the U.S., organized by FAUSA. Both conferences were very successful and drew FAWCO club members from around the world. We look forward to the opportunity to plan the next one.

It has been a great pleasure for the FAUSA board to work closely with the boards of both FAWCO and The FAWCO Foundation, and we look forward to expanding and deepening that relationship in the future.
